




HEART was not included as any of the reviewed or recommended materials.</li> </ul> </li> <li>Q: Do these materials “oversexualize” students and teach them how to have sex? <ul style="list-style-type: none"> <li>None of the required content in CHYA, and therefore in Teen Talk, teach students how to have sex.</li> <li>CHYA requires: “Information on the manner in which HIV and other sexually transmitted infections are and are not transmitted, including information on the relative risk of infection according to specific behaviors, including sexual activities.” and “Information that abstinence from sexual activity and injection drug use is the only certain way to prevent HIV and other sexually transmitted infections and abstinence from sexual intercourse is the only certain way to prevent unintended pregnancy.”</li> </ul> </li> <li><b>Parental Rights:</b> <ul style="list-style-type: none"> <li>As required by law, a required notification (<a href="#">Eng</a>, <a href="#">Span</a>) is provided at least 14 days in advance of instruction.</li> <li>Notification states” If you do not want your student to participate in all or parts of the comprehensive sexual health or HIV prevention education, please provide a signed, written note to the Conejo Valley Unified School District, your school site Principal and your student’s 7th grade Science/High School”</li> <li>Provided in Annual Notification (p. 2) provides all required information and rights for annual notice at beginning of year and for students who enroll during the school year.</li> </ul> </li> </ul> <p><b>Opt-out Information:</b> 77 students out of 2,069 (3.7%) opted out of all the Teen Talk curriculum to date - 96.3% of the parents had their students participate in the Teen Talk curriculum to date.</p> <p><b>Parent Survey Results:</b> 159 parents out of 2,873 (5.5%) parent respondents (last year’s second semester classes) completed the District Parent Survey. The results included 13% provided positive feedback; 61% provided neutral feedback; 22.5% provided negative feedback; 3.1% provided both positive and negative feedback; 6.2% provided feedback on instructional practices; 20.9% provided feedback on content</p>

For the last 3 years, CVUSD has posted these videos for families to review at any time.</p> <p>A dedicated <a href="#">webpage</a> was created last year with all the videos, notification, and FAQ provided to families.</p>	<ul style="list-style-type: none"> <li>These videos were first implemented in 1986, and more modern versions of these videos were purchased in 2012 and 2021.</li> <li>Last year, the Board directed staff to annually review resources for new and updated video materials.</li> <li>Last year, the Board approved additional videos for some students with disabilities.</li> <li>Last year, the Board directed all videos to be shown to all students. 			<p>CVUSD boundaries)</p> <p>Statewide enrollment trends experienced the fifth consecutive decrease in enrollment in the 2021-22 school year, with a loss of 110,000 (roughly 1.84%) students. In fact, the last time student enrollment was this low was in 1998-99, more than 20 years ago. If current trends hold over the next ten years, further decline of 523,700, roughly 8.9% of 2021-22's total enrollment, is projected. <p><b>School Closures Due to Size / Enrollment</b></p>			<p>This has not been a topic/discussion during the past 10 years or since the last set of school closures. The discussion and decision to close schools was made by previous school Boards and administration many years ago. The current CVUSD school Board members and district leadership have never had a conversation about closing schools.</p>

### Highlights for this school year:

- Completed the County's only Comprehensive Annual Financial Report (CAFR) two years in a row. Improves transparency and reporting to the general public.
- Launched the first DLI program in CVUSD, with the first DLI TK and K students starting in the 22-23 school year with 1 TK class and 3 K classes. This effort included information webinars, staff meetings with families in the neighborhood, tabling at area preschool programs, and online advertising. The District/School Site was hoping for 40 interested families and received 80 interested families.
- Pilot three sections of Ethnic Studies (one at each comprehensive HS) during the 2022/23 school year.
- A total of 8 new credentialed Physical Education teachers were hired to provide 30 minutes of PE instruction to all TK-5 students at least every 10 days. This is in addition to and in conjunction with the Physical Education provided by academic specialists.
- A total of 2.2 new credentialed General Music teachers were hired to provide 30 minutes a week of General Music instruction to all 4th and 5th Grade students throughout CVUSD.
- Three additional "College and Career Readiness Counselors" were hired as part of the UC A-G Improvement Grant. These new counselors are at each comprehensive high school and dedicated to providing proactive information to high school and middle school students and families about UC A-G requirements. Counselors will work with staff and other counselors to identify students who need additional support to become or maintain UC A-G compliant.
- Implemented our plan to diversify our administration team for the 2022-23 school year. Posted positions to a variety of websites (added statement of DEI). Posting jobs include the following: Indeed, Diversity in Ed, HBCU, Professional Diversity Network, CALSA, CAAASA, CAAPLE, ACSA Diversity, Black Jobs, and Black Career Women's Network. Colleges: CSUN, CSUDH, CSULA, CSULB, CSUCI, UCLA, UCSB, USC, Pepperdine, CLU, and Ventura County Community Colleges.
- Hired 7 Mental Health Clinicians, Increased Mental Health Associates (ISBTs) from 11 to 15. (That is a wonderful increase as there were only four ISBTs 6 years ago!) Increased our agreements with universities from 3 to 7, which allowed us to bring on 20 mental health trainees and has increased the number of Mental Health interns from 6 to 20. Middle schools will also have their own Wellness Room on campus this year. This is similar to the high schools, where Wellness Counselors will provide individual and small group supports.
