BOARD OF EDUCATION REGULAR BOARD MEETING Tuesday, October 11, 2022

MINUTES

1. CLOSED SESSION

A. Comments - Public

President Sylvester announced that there were no public comment requests received, and the Board convened into Closed Session at 5:00 p.m. where the following items were discussed:

President Sylvester was notified during Closed Session that there were two (2) public comment requests submitted on Agenda Item 1C prior to the start of Closed Session, and the Board paused Closed Session to allow for public comments. Each speaker received three (3) minutes to speak, and the Board then convened back into Closed Session.

5. INFORMATION/DISCUSSION ITEMS – GENERAL

A. Instructional Services - Presentation: Co-Teaching

Mr. Loo presented information on the Co-Teaching Program, which included a description of the co-teaching process and cycles, definition of co-teaching models, professional learning opportunities, areas of success and continuous improvement, elementary and secondary co-teaching classes, data collection to monitor student performance, and co-teaching in the least restrictive environment. Mr. Loo answered questions from Board members regarding the process for selecting co-teaching partners, feedback from current co-teachers on strengths and

challenges, subjects best suited for co-teaching at the secondary level, consistency across all high schools, and primary roadblocks.

B. Instructional Services - Presentation: Outdoor School

Mr. Loo provided an overview of the 2022-2023 Outdoor School program at Camp Ramah, which included an introduction of Tom Hoegeman, Outdoor School Coordinator, background of Outdoor School, schedule and description of the camp experience, curriculum focus, review of supports for access and equity, procedures for health and safety, student cost, allergy friendly meal options, and parent information nights for students in specialized programs. Mr. Loo answered a Board member's question regarding the difference between the camp experience for sixth and eighth grade students.

C. Board of Education – Approval of Amendments to Board Bylaw 9320 – Meetings and Notices

Dr. McLaughlin provided background on the amendments to this Board Bylaw, which included changes in law regarding the Brown Act and virtual meetings. In addition to the amendments, he stated that the District will be adding the ability, through our Swagit system, to translate and provide closed captioning of our live Board meetings, with the anticipation that this service will be available in December. Dr. McLaughlin answered a Board member's question regarding the District's ability to provide translation and closed captioning of Board meetings in Spanish, as well as other languages.

D. Board of Education – Approval of Amendments to Board Bylaw 9322 – Agenda/Meeting Materials

Dr. McLaughlin stated that the amendments to this Board Bylaw are basic updates from the California School Board Association's Gamut policy service. There was no Board discussion on this agenda item.

E. Student Services – Approval of Amendments to Board Policy and Administrative Regulation 5141.31 – Immunizations

President Sylvester clarified that the amendments to this Board Policy and Administrative Regulation were updates to reflect law. There was no Board discussion on this agenda item.

F. Community Member Request – Carden Westlake Village, Inc. Request for District Approval and Execution of Consent to Assignment of Lease Agreement to Carden Conejo School, a California Nonprofit Public Benefit Corporation

President Sylvester announced that there were two (2) public comment requests submitted, and each speaker received three (3) minutes to speak. President Sylvester stated that the Board had earlier discussion on this agenda item during Closed Session, and that the next step regarding this request would be further conversations with Dr. Victor Hayek. There was no Board discussion on this agenda item.
