Presentation: School Safety

#### 1. Comprehensive School Safety Plan

- Updated every year
- Addresses the full spectrum of campus safety issues
- Conforms to FEMA required incident management structure
- Contains disaster specific response protocols
- Scheduled fire, earthquake, and lockdown drills
- Response consideration for students with special needs
- Active shooter response trainings
- Campus perimeter security and visitor management
- Emergency supplies (classroom and central supply)

#### 2. Security Improvements in Progress

- Main entrance control- Visual/voice confirmation and electronic look at all schools
- Expanded use of card key access control
- Increasing the number of staff that is CPF/First Aid certified
- Add and replace handheld radios use in an emergency situation
- Participation in VCSSFA security assessments and seminars

## Meeting Minutes

1. Learners must be able to communicate and collaborate effectively with a community of learners.
  2. Peer cooperation can significantly increase the available support for sustained engagement.
  3. Flexible rather than fixed grouping allows better differentiation and multiple roles, as well as providing opportunities to learn how to work most effectively with others.
- Goal is to build community among students and foster social-emotional wellness overall. This is also important as a means for monitoring mental health among students who may prevent red flags for violence in the future. So this is being seen as a potentially preventative measure against future gun violence.
  - Anti-bullying efforts remain in effect. Posters are in all secondary schools and anti bullying posters will be available for elementary level schools shortly.
  - A confidential reporting form is available if a family or student or family are in need of support, specifically related to experiences with racism, discrimination, harassment, and/or bullying. This can also happen through the CVUSD website.
  - WeTip- is a new reporting solution platform to address and prevent bullying, discrimination, physical abuse, threats, concern for self/others harm and crime will be available to the district in the next 4-6 weeks. This program allows for reports to be sent after school hours, on weekends and also during school hours. Operators will triage urgent reports to law enforcement. Reporters remain anonymous while allowing continuous communication with school staff and WeTip operators.
  - Middle School and High Schools are seeing great results from their campus Wellness Rooms. At this point they are only available at secondary school levels.
  - Red flag internet searches happen every 24 hours on all district issued devices pertaining to self/other harm.
  - Recap from several DAC reps on various back to school events to foster social emotional learning & wellness (morning meetings, coffee with PFA/Principal, etc).
