III. Information/Discussion Items

- A. Information/Presentation: Expanded Learning Opportunities by Harmoni Esterberg, Coordinator of Expanded Learning Opportunities Program
 - Ms. Esterberg provided information about the ELO-P program. She shared the following:
 - What is ELO-P?
 - The Expanded Learning Opportunities Program (ELO-P) is funded by the state of California to create and/or support enrichment programs for students in TK-6th grade.
 - ELO-P at CVUSD
 - CVUSD offers the following programs through ELO-P:
 - ➤ Academic: Built in time Monday-Thursday for every student to complete their homework.
 - ➤ Enrichment: Curriculum built on weekly thematic units such as "Fun Fridays" that include either an art or STEAM culminating activity.
 - Collaboration: Community based organizations, assemblies, field trips, etc.
 - TK 5th Grade

- This program is offered at the following schools:
 - TEAM: Banyan, Cypress, EARThS, Lang Ranch, Sycamore, Walnut, Weathersfield, Westlake and Wildwood.
 - > RAS: Conejo, Glenwood, Ladera Stars and Madrona.
 - > STAR: Aspen, Maple and Westlake Hills.
 - ➤ CRPD: Acacia
- B. Information/Presentation: DELAC Overview by Dr. Ricardo Araiza, Director of Multilingual Learners
 - 1. Dr. Araiza gave a presentation on DELAC Training. He shared the following:

■ Purpose of DELAC:

- Provide input on the Master Plan for English Learner
 Success and the Single School Plan for Student Achievement
- Conduct a district-wide needs assessment on a school-by-school basis
- Establishment of district programs, goals, and objectives for programs and services for English learners (e.g., parental exception waivers and funding).
- Development of a plan to ensure compliance with any applicable teacher and instructional aide requirements
- Review and comment on the District's reclassification procedures

Members:

 A member is defined as an elected representative from each school in the District and who is a parent of an English Learner or former English Learner (RFEP).

■ Voting:

 Each school representative may cast one vote on each matter submitted to a vote by DELAC. Decisions shall be made by a simple majority of those present entitled to vote. Any vote on a major issue such as funds, policy, or program changes shall be taken by roll call unless the vote is unanimous.

Officers:

- Officers of the DELAC shall be a President, Vice President, Secretary, Parliamentarian and the DELAC Representative to the District Advisory Council. These members shall constitute the executive board.
- The officers do not need to be voting members of the DELAC.
 The president and DAC representative or secretary positions may be combined or shared positions. The officers are not required to be bilingual but they need to be knowledgeable of the English learner program.

■ DELAC Meetings:

- The District English Learner Advisory Committee meets 8 times.
- The meetings shall be held at the district offices (or a CVUSD building/classroom) and special meetings shall be called by the executive board or may be called at the request of twenty percent of the regular voting members.
- Notices of meetings shall be sent to all relevant stakeholders.

Amendments:

 Bylaws may be amended at any regular meeting of the DELAC by a two-thirds vote of the membership, provided that the amendment has been submitted for consideration at the previous meeting.

C. Information/Presentation: Needs Assessment by Dr. Ricardo Araiza, Director of Multilingual Learners

 Dr. Araiza reviewed the Needs Assessment Survey results that were sent to parents/guardians of multilingual learner students in May 2023. This survey was sent to over 2,000 parents/guardians to which 89 parents/guardians responded.

- Ana Alvarez shared information about ESL classes that are taking place at Acacia, Conejo Creek and Walnut. These classes are scheduled from 8:30 am to 10:30 am.
- Dr. Dwight Rogers, Director of Diversity, Equity and Inclusion shared information about the Latino College Expo that took place on Saturday,
