Comments from Support Groups

Aleta Smith, Conejo Council PTA President, discussed the various PTA newsletters at the schools and all the information that is disseminated to families, including current legislation, traffic safety, health issues, homework help, and services available to the families. Ms. Smith also related a discussion that the state PTA president had with Governor Schwarzenegger regarding the budget crisis and other issues regarding education. The next Child and Adolescent Disorder Seminar will be at the Thousand Oaks High School Library on Tuesday, January 22, 2008, at 7:30 p.m.

Sue Wells, District Advisory Council Chair, reported from the December meeting, where the Manzanita SCRUBS (5th graders participating in a cross-curricular service-learning program to help restore native habitats in the Santa Monica Mountain National Recreation Area) presented their program, Eilene Green, Horizon Hills Parenting Program Coordinator, reviewed the Adult Education catalog, and Georgette McBreen, Coordinator of the Parent Talk/Teacher lecture series reported that the series provides nationally recognized speakers. Phil Nelson, Director, Planning and Facilities, discussed the elementary school closure procedure, criteria used to evaluate schools for closure and definitions of terms used in the process.

Pam Garvin, President, Conejo Schools Foundation, was proud to announce that the Foundation received a \$100,000 donation from the Power family, in honor of Julie P. Power, a former teacher and strong supporter of education in the Conejo Valley Unified School District. All of Mrs. Power's children attended CVUSD schools and her grandchildren are currently attending our schools. The Power gift will support a new science program at Thousand Oaks High Schools, Geo Science, the honors Physical Science course at Middle Schools, and the program called "Parents Making a Difference" project – an education for English-learning adults. The gift will also add to the Foundation's endowment for long-term funds. Many thanks to the Power family for their generosity. Foundation Board members Bob and Renee Nunn also gifted the endowment with \$5,000 and challenged other Foundation Board members to do so. Many thanks to the community for continued support.
