January 13, 2004 <u>MINUTES</u>

The Conejo Valley Unified School District Board of Education met in Regular Session on January 13, 2004, at the District Office Board Room, 1400 East Janss Road, Thousand Oaks, California.

CALL TO ORDER

Present were Board members Dorothy L. Beaubien, Mary Jo Del Campo, Dolores Didio, Patricia H. Phelps, and Timothy G. Stephens. Also present were Robert Fraisse, Superintendent, Richard Simpson, Assistant Superintendent, Instructional Services and Jody Dunlap, Assistant Superintendent, Personnel Services, Dr. Jeffrey Baarstad, Assistant Superintendent, Business Services. Chuck Eklund, Director, Secondary Education was also present.

The Closed Session meeting was called to order at 5:00 p.m. by Dorothy Beaubien, President.
