Dr. Baarstad mentioned the Public Forum that is being held on February 10, 2015, at 6:30 p.m. for community members to offer their input in regard to the search for the next Superintendent (Dr. Baarstad will be retiring as of June 30, 2015). Dr. Connolly explained that the search firm of McPherson & Jacobson will be conducting the community forum, as well as the (open) meetings with constituent groups on Tuesday, February 10 and Wednesday, February 11, in the Board Room.

One speaker commended school counselors and asked that the school community acknowledge and thank them during National Counseling Week. One speaker complimented Dr. Jennifer Boone for her response to questions and suggestions about the Accountability Report Cards.

Comments from Individual Board Members

Mrs. Phelps discussed a meeting she and other school community members had with the Ventura County District Attorney regarding the operation of the District Advisory Council (DAC) and compliance with the Brown Act. They all felt that the District Attorney provided important information regarding future meetings. Mrs. Buckles spoke about her experience at a Career Technology Committee meeting, and announced that there will be a Career Technology Education Showcase on Monday, February 23, 5:30 – 7:30 a.m. at the Teen Center. This would be a great opportunity for families to learn about the career technology programs at the high schools. Mrs. Buckles commended the 8th grade students and staff for the *We the People* program she attended last week. Mrs. Buckles also announced that the City's Community Internship Training Youth (C.I.T.Y.) will host an Internship Fair on Thursday, February 19 from 6-7:30 p.m. at the Civic Arts Plaza Kavli Theater for students entering their senior year in the fall of 2015. Dr. Connolly added to Mrs. Buckles' comment about the Internship Fair that the group is also seeking businesses willing to intern a high school student.
