## February 4, 2014 <u>MINUTES</u>

# **DISCUSSION SESSION – BUDGET PRIORITIES**

At 4:05 p.m., President Peggy Buckles opened the Discussion Session, and asked if there were any speakers to the agenda item. There were none. Dr. Baarstad provided a suggested outline for the meeting and a presentation with current budget projections. Dr. Baarstad provided information on the Local Control Funding Formula (LCFF) and the Local Control Accountability Plan (LCAP). Dr. Baarstad explained that the "new" money will come in the form of Supplemental Base Grants which target English Learners (EL) and Socio-Economic Disadvantaged (SED) students.

Dr. Connolly asked if schools with higher EL and SED populations would receive more money. Dr. Baarstad responded that in general, yes, but the District has some flexibility in how the money is provided to sites.

Mr. Dunn asked if personnel would have input to decide on expenditures of funds. Dr. Baarstad stated that the District is required to consult with the three bargaining units on new funds. Mrs. Phelps stated that the Budget Committee has representation throughout the District and was extremely helpful during the cuts. She expects that the committee would also be included in discussions about appropriation of new funds.

The Discussion Session ended at 4:52 p.m., and the Board convened into Closed Session.

# **CLOSED SESSION**

At 5:05 p.m. President Peggy Buckles announced that the Board would convene into Closed Session, and asked if there were any public speakers for the Closed Session agenda items; there was one. The speaker spoke to the Closed Session Agenda item regarding the Uniform Complaint.

The Board convened into Closed Session at 5:15 p.m., to consider E. Consideration of Confidential Student Issues Other Than Expulsion, 1. Review of Uniform Complaint Pursuant to Board Policy/Administrative Regulation 1312.3.

The Board returned to Open Session at 6:07 p.m.

Dr. Connolly moved to <u>sustain the December 19, 2013</u> decision of the Compliance Officer, Mr. Robert Iezza, regarding the uniform complaint dated November 20, 2013, seconded by Mrs. Phelps. Mr. Dunn read a statement in opposition to the motion. Motion carried 4-1 (Buckles, Connolly, Phelps and Stephens – Yes; Dunn – No.) Board President called for a five minute recess.

# **REGULAR SESSION**

## **OPENING PROVISIONS**

#### **Regular Board Meeting**

Call to Order and Roll Call: President Buckles called the meeting to order at 6:12 p.m., read the procedural announcements and welcomed everyone to the meeting. Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps and Dr. Timothy Stephens. Administration: Dr. Jeffrey Baarstad, Superintendent, Robert Iezza, Assistant Superintendent, Instructional Services, Linda Bekeny, Assistant Superintendent, Business Services, and Mark McLaughlin, Assistant Superintendent, Personnel Services. Dr. Jeff Davis, Director, Secondary Education, Carol Boyan-Held, Director, Elementary Education, and Dr. Jon Sand, Director, Curriculum & Assessment, were also present.

#### Approval of the Agenda

Mrs. Phelps moved to <u>approve the agenda with the following request: remove items B, C, and D from the Consent</u> <u>Agenda to be discussed in Closed Session after the Open Session</u>, seconded by Dr. Stephens. Dr. Baarstad clarified that the Board only discussed one issue in Closed Session and has several more agenda items to deliberate. Therefore, the Board will reconvene in Closed Session at the conclusion of the Open Session agenda. Following the second Closed Session, the Board must return to Open Session to vote on the Consent Items B, C, and D. Motion carried 5-0.

Motion carried 5-0.

Dr. Davis confirmed that high school principals were surveyed and all reported that International Exchange students, with one exception a few years ago, are treated as juniors and therefore, not available for senior activities.
