CALL TO ORDER - CLOSED SESSION

The Board meeting of February 1, 2008, was called to order by President Dorothy Beaubien at 5:00 p.m. Mrs. Beaubien asked if there were any public speakers for the Closed Session agenda items; there were none. <u>CALL TO ORDER – OPEN SESSION</u>

OPENING PROVISIONS

President Beaubien called the meeting to order at 6:03 p.m., led the Pledge of Allegiance, and read the procedural announcements for the meeting.

Present were Board members Dorothy Beaubien, Dolores Didio, Mike Dunn, Pat Phelps, and Dr. Timothy Stephens. Administration: Mario V. Contini, Superintendent, Jo-Ann Yoos, Assistant Superintendent, Personnel Services, and Janet Cosaro, Assistant Superintendent, Instructional Services. Bob Iezza, Director, Elementary Education, Max Beaman, Secondary Education, Carol Boyan, Director, Curriculum, were also present.

Approval of Agenda

Mrs. Didio moved to <u>approve the agenda</u>, seconded by Mrs. Phelps. Mr. Dunn asked if people would be allowed to speak on Item D under Information Items: Proposed Land Initiative "Right to Vote on Traffic Congestion." Mrs. Beaubien replied yes, that the Board will listen to the public speak on any and all topics that are on the agenda. Motion carried 5-0.

Read Across America Presentation

Susan Falk, UACT President, Colleen Briner-Schmidt, representing UACT and Janet Cosaro, representing the District, presented a skit and a resolution for *Read Across America Day*, March 3, 2008, in honor of Dr. Seuss's birthday, March 2. This is the District's 11th year to celebrate *Read Across America Day*.

Comments from the Superintendent

Superintendent Contini: 1) reported that Thousand Oaks and Westlake High Schools were included in a list of best schools in the nation by U.S. News and World Report, in collaboration with School Evaluation Services (a K-12 education and data research and analysis business). Criteria included academic and enrollment data. 2) congratulated Meadows, Lang Ranch, and Sycamore Canyon for moving to the next step in the California Distinguished Schools process. We understand the incredible amount of work that goes into the application, and wish them success on advancement through the next phase. 3) announced that the new District website home page is now active, even though it's still "under construction." It uses the same address (www.conejo.k12.ca.us) as in the past, and then connects to the old website that is still in use. This website will only be for the district offices as the schools each have their own. We will continue to build this site and expect to have the old site phased out by July 1. 4) explained the "infrastructure gridlock" taking place at some of our sites due to network saturation on an antiquated system. A test was run at Thousand Oaks High School and found it running at 139% of capacity. It was explained that that would be like trying to put 7 pounds of flour in a 5 pound bag. Unfortunately, our old system cannot accommodate traffic management systems that would normally be used to "fix" the situation. The solution will probably have to be done manually, and scheduling of schools to access Zangle during specific times when other schools will be off Zangle. There will be more information on this in the future. 5) congratulated Stan McClain, CSEA President, for his 35 years of service in the District. Stan will be retiring from his custodial position with the District as of Wednesday, February 20, but will remain as the President of CSEA, a position he has held off and on for the past 19 years!

Comments from the Public

20 individuals spoke to the issue of school closure, 3 to the issue of Special Day Classes, and 2 to the issue of the proposed "Right to Vote on Traffic Congestion" (information item D). The Board also received 3 Public Written Statement forms regarding school closures.

Comments from Individual Board Members

Mrs. Didio spoke about attending a wonderful Patriotic Program in Kindergarten classes at Weathersfield Elementary School. The teachers (Lynn Quick and Helene Goldstein) used music and art as part of the program.

Mr. Dunn asked if the district had a hiring freeze; Mr. Contini stated yes except for essential positions.

INFORMATION ITEMS

Board of Education and Superintendent

Resolution #07/08-20: Opposition to the Governor's State Budget Proposal. There was one speaker to this topic. Mrs. Didio stated that one of the biggest problems with the budget was the Governor's after-school proposal, which we cannot touch because it's categorical. So much money was set aside for this initiative. Dr. Stephens stated that we are 46 out of 50 states in terms of per pupil funding for public education. We are seventh in the world in wealth. Mrs. Phelps pointed out that if the legislature had to follow the rules that the school districts do in terms of putting aside money for bad years, we may not be in this situation. Mr. Dunn stated that businesses have a difficult time making a profit in this state, and that, along with NAFTA, are a huge problem. Mr. Contini gave some factual information on the budget. This week was the deadline for the legislature to take emergency session of the legislature. Last week they proposed \$1 billion in cuts mid-year for this year, looking for funds that have not been spent yet and trying to cover the short fall in that way. There are about \$1.2 billion that do not affect education, and about \$1 billion that will. The legislature tried to address a tax loophole for tax breaks for individuals who buy yachts and airplanes out of state, and they were unable to come to terms with that one. Had they come to terms with that one, the state would have saved about \$5 million this year and about \$21 million next year in tax loopholes. One serious issue that we are concerned about is they did approve a one-time deferral of July's apportionment moving it to September. Essentially, this two month's deferral means that school districts across the state will have to dip into tax revenue anticipation notes (TRANS), which could cause extra costs to districts. The legislature can still go back and make more additional cuts for this current year. Next year's proposal still includes suspending Proposition 98, which was approved by the voters several years ago to set a floor for funding of public schools. It still includes a reduction in the COLA for about 6.5%, which moves it from a 4.5% to a negative 2%. There is some belief that will not happen but it is still in the plan. The Governor's proposal still includes 10% across the board for cuts, and he does still include the June apportionment to September. The legislative analyst is expected to share some new updated information on the projects, and it is expected to look even worse. In May the legislature will get their final estimates from the Department of Finance and then the Governor will come out with his May Revise. An interesting point is that since 1999, the State budget has gone up 81%, education has gone up 69% and that number will drop to a lower percentage – an expected 58% with the cuts expected. These are massive and serious issues for schools. Mr. Dunn stated that interest on the debt is one of the biggest problems in our State.
