CALL TO ORDER - REGULAR SESSION

OPENING PROVISIONS

Call to Order and Roll Call: Dr. Connolly called the meeting to order at 6:15 p.m. Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps and Dr. Timothy Stephens. Administration: Dr. Jeffrey Baarstad, Superintendent, Timothy Carpenter, Assistant Superintendent, Personnel Services, and Linda Bekeny, Assistant Superintendent, Business Services. Also present were Robert Iezza, Director, Elementary Education, Dr. Jeff Davis, Director, Secondary Education, and Carol Boyan-Held, Director, Curriculum.

Dr. Connolly read the procedural announcements and welcomed everyone to the meeting.

Approval of the Agenda

Mrs. Phelps moved to approve the Agenda with an amendment to the agenda item IV. Action Items – General, Instructional Services J. Approval of New Core Literature Title for English 9CP, seconded by Dr. Stephens. Motion carried 5-0.

Presentation: Read Across America Day

Janet Cosaro, Colleen Briner-Schmidt, President, Unified Association of Conejo Teachers (UACT), and Donna Mazza, Teacher, Redwood Middle School, presented a Dr. Seuss-type skit to the Board and community as a reminder that March 2 is "Read Across America Day."

Comments from the Superintendent

Dr. Baarstad made a public announcement regarding the retirement of Janet Cosaro at the end of the school year, and expressed his respect and gratitude for Ms. Cosaro's professionalism and knowledge. Dr. Baarstad congratulated the secondary school bands who have each had a student selected to perform with the California Honor Band.

Comments from the Public

One public speaker discussed the legalities of holding a public hearing on the waiver for the Romero Bill that was voted on at the February 7 Board meeting. Staff will investigate the process and make any corrections needed at the March 13 Board meeting. One speaker offered the Board the CSEA (California School Employees Association) new contract points of negotiations as part of the "Sunshine" process.

Comments from Individual Board Members

The Board members each offered their praise and appreciation to Ms. Cosaro for her 35 years of dedication to education. Mrs. Phelps also mentioned the excellent annual Chinese New Year's Celebration event at the Civic Arts Plaza that featured many of our students.

Dr. Stephens moved to approve Resolution #11/12-17, as submitted, seconded by Mrs. Phelps. One public speaker discussed the legality of the process being used to determine teaching positions that will be retained regardless of seniority. Motion carried 4-1, with Mr. Dunn voting nay.

D. Resolution #11/12-18: Determination of Competency Among Employees Possessing the Same Credential Mrs. Phelps moved to approve Resolution #11/12-18, as submitted, seconded by Dr. Stephens. Motion carried 5-0.

E. Resolution #11/12-19: Ordering Seniority of Certificated Employees Who First Rendered Paid Service on the Same Day

Mrs. Buckles moved to approve Resolution #11/12-19, as submitted, seconded by Mrs. Phelps. Motion carried 5-0.

F. Adoption of Exhibit 4144, 4244, 4344 – Complaint Submittal Form

Mr. Dunn moved to <u>adopt the proposed Exhibit 4144, 4244, 4344 – Complaint Submittal Form</u>, seconded by Mrs. Buckles. Motion carried 5-0.

G. Resolution #11/12-20: Week of the School Administrator (March 4-10, 2012)

Dr. Stephens moved to adopt the attached proclamation declaring March 4-10, 2012, as the "Week of the School Administrator," seconded by Mrs. Phelps. Dr. Stephens commented on the dedication of the administrative staff, especially at a time when they have more demands with fewer resources. Motion carried 5-0.

H. Approval of Resolution #11/12-13: Read Across America Day

Mrs. Buckles moved to adopt resolution #11/12-13, seconded by Mrs. Phelps. Motion carried 5-0.

I. Approval of Extended Day Kindergarten – Maple Elementary

Mrs. Phelps moved to approve the extended day kindergarten at Maple Elementary for 2012-2013, seconded by Mr. Dunn. Motion carried 5-0.

J. Approval of New Core Literature Title for English 9CP

Dr. Stephens moved to approve the new core literature title 9 (the Hunger Games), seconded by Mrs. Phelps. Motion carried 5-0.

K. Approval of New Core Literature Title for English 12CP

Dr. Stephens moved to approve the new core literature title (the Kite Runner), seconded by Mrs. Phelps. One public speaker spoke in opposition to this adoption, stating that the content of the book is not appropriate for high school students. Mr. Dunn stated his concern about the mature content of the book (rape, sexual abuse), and referenced a review of the book from an on-line source. Mrs. Boyan-Held informed the Board that the book was approved last year for the Advanced Placement classes due to the reference to the book in the Advanced Placement exam. This year, the Language Art Articulation Committee decided that the CP students

should also be prepared for the essay portion of the SAT exams, where reference to this book has appeared. Motion carried 4-1, with Mr. Dunn voting nay.
