Dr. Jeff Davis, Director, Secondary Education, Jeanne Valentine, Director, Elementary Education, David Fateh, Director, Planning & Construction, Sandy Curwood, Director, Child Nutrition, and Marina Mihalevsky, Director, Classified Personnel, were also present.

Dr. Connolly read the procedural announcements and welcomed everyone to the meeting.

## Approval of the Agenda

Mrs. Phelps moved to approve the agenda, seconded by Mrs. Buckles. Motion carried 5-0.

## **Recognition of Marmonte League Champions**

The Board recognized the Thousand Oaks High School Boys Basketball and Wrestling teams for their Marmonte League Championships.

## **Comments from the Public**

Twenty-two Public Speaker Forms were submitted.

One speaker addressed the issue of free high school summer school offered in Simi Valley.

Twenty-one speakers addressed the issue of the article in the Newbury Park High School student magazine, the Panther Prowler, "Let's Talk About Sex." Seventeen speakers were opposed to the article and administrative approval of the article. Four speakers spoke in support of the article.

## **Comments from the Superintendent**

Dr. Baarstad had no comments.

## **Comments from Individual Board Members**

Mrs. Phelps stated her pleasure that the District Advisory Council (DAC) meetings seemed to have returned to productive exchanges of parents' concerns and ideas.

Mr. Andersen thanked everyone for attending the Board meeting regardless of the side they may align with in regard to the Panther Prowler article. Mr. Andersen mentioned attending the strings ensemble at Newbury Park High School and the Healthy Kids seminar.

Mrs. Buckles discussed attending the Envisioning the Future Career Technology dinner at California Lutheran University, which had many students from around the district and community business leaders discussing entrepreneurship opportunities.

Mr. Dunn addressed some of the concerns in the emails he received regarding the Panther Prowler article, and asked Prowler student editors, who were present, to clarify some questions he had.

Dr. Connolly commended the students and staff involved in the TEDx presentation at the Thousand Oaks High School Performing Arts Center on March 15. Dr. Connolly stated that the presentations were outstanding!

## ACTION ITEMS – GENERAL

## **Board of Education**

A. Action Item Requesting Panther Prowler Magazine Print a Written Uncensored Rebuttal with Front Page Picture in Response to 2/27 "Let's Talk About Sex" Article

Mr. Dunn moved to approve issuing a written request to the Panther Prowler magazine asking the magazine staff to print a written uncensored rebuttal with front page picture from Garry Pace in response to the Panther magazine

article entitled, "Let's Talk About Sex," seconded by Mr. Andersen. Dr. Connolly stated that she would like to hear from the people who submitted public speaker forms first.

Twenty-one Public Speaker Forms were submitted

Ten forms were submitted in support of Mr. Dunn's action item and/or opposed to the Prowler article. Eleven cards were submitted in opposition to Mr. Dunn's action item and/or in support of the Prowler article.

Mr. Andersen and Mr. Dunn explained that they feel that the action item would help to mend the community's concerns about the Panther Prowler article by offering equal opportunity for an opposing view in the magazine.

(For clarification, it was explained that the article being discussed, "Let's Talk About Sex," was published in the annual magazine that the journalism students publish. The next publication of the magazine would be sometime in in 2016. However, the Panther Prowler also publishes a monthly newspaper. Therefore, any future articles that would address "Let's Talk About Sex" would have to be published in the Panther Prowler newspaper.)

Dr. Connolly explained that she could not support the action item as she believes that as a student publication, it is protected under the Constitution and Ed Code guarantees of Freedom of the Press, and that while the article and picture may have pushed the boundaries for some families, it opened the opportunity for some to begin dialog on the subject. Dr. Connolly also stated that as a student newspaper/magazine, only journalism students in the class should write the articles.

Mrs. Phelps stated that if others wanted to address their displeasure with the picture and article, they should submit their comments to the Letters to the Editor section of the newspaper.

Mr. Dunn asked if Board members would consider modification of his original motion to take the adult name out of the motion, and replace it with "Approve issuing a written request to the Panther Prowler magazine asking the magazine staff to print a written uncensored rebuttal with front page picture from Garry Pace students in response to the Panther magazine article entitled "Let's Talk About Sex." Mr. Andersen seconded the motion. Motion failed 2-Yes (Andersen, Dunn), 3-No (Buckles, Connolly, Phelps).

Dr. Connolly addressed the student journalists present, indicating the Board action was leaving the content of the next newspaper edition to their judgment, and that she hoped they would exercise that judgment wisely.

## Change in the Order of the Agenda

Mrs. Phelps moved to amend the order of the agenda to have <u>Information Item VI. E. Resolution #14/15-14</u>: <u>Authorizing the Issuance of CVUSD Election of 2014 General Obligation Bonds Series A and Actions Related Thereto</u> discussed at this point in the Agenda. Motion carried 5-0. Mr. Timothy Carty, representing Piper Jaffray, the District's Measure I Bond counsel, explained the issuance process to the Board and answered their questions. The Resolution will return as an Action item at the March 31, 2015, board meeting.
