Reports from Student Board Members

Jennifer Randolph, Thousand Oaks High School, sat with the Board. Samantha Gilbert, Westlake High School, Melissa Siple, Conejo Valley High School, Ben Wallace, Century Academy, and Marianne L'Engle, Newbury Park High School, joined Jennifer to report on campus events such as blood drives, ASB events, rallies, senior activities, anti-drinking/driving activities, dance showcases, athletics, drama, choir, Prom activities, fashion shows, career activities, ROP programs, Spring Fling Dance, TEDX event, cheer try-outs and more.

Reports from Support Organizations

Mike Soules, President, Conejo Schools Foundation, thanked Pratt-Whitney Rocketdyne for the \$9,500 science grant that was just awarded. Mr. Soules informed the community that all the coins that end up in the water features at the Oaks Mall are scooped up and donated to CSF. He thanked the Oaks for their kind donations. Lilly Dollenmayer, Chair, District Advisory Council (DAC), reported from the last meeting: 1) Dean Vogel, President Elect for the California Teachers' Association (CTA) provided information regarding teacher evaluations and other educational issues. 2) Dr. Christina Palmer, Principal, Maple Elementary School, presented information about the school's science lab. 3) Susan Wilson, School Nurse, provided information regarding immunizations for students in grades 7-12. 4) Jerome Staszewski, Director, Technology Services, outlined the installation progress of the off-lease computers, and 5) Dr. Baarstad reported on possible budget scenarios.

Comments from the Superintendent

Dr. Baarstad 1) congratulated all the scholars and athletes honored for their great successes, 2) announced that the District just heard from the California Department of Education that Sequoia Middle School has received designation as a California Distinguished School. Sequoia Middle School is the only secondary school in Ventura County to have received this designation this year. He congratulated Vivian Viña, Principal, and all the students and staff for their hard work and dedication to excellence, and also thanked Phil Gore at the Ventura County Office of Education for his support and dedication to help schools with the Distinguished School Program.

Two public speakers offered information about the elementary counseling programs offered at CVUSD.

Comments from Individual Board Members

Mrs. Phelps apologized to the Conejo Council PTA and Lang Ranch Elementary for not attending the Reflections Gallery Night this year, as she looks forward to the event each year. She also mentioned that she was amazed to hear at the Technology Committee meeting about all of the tremendous opportunities and programs that teachers and other staff reported on from the CUE (Computer Using Educators) Conference. Mrs. Phelps also announced that the Technology Committee is offering a newsletter, which can be found on the district website under the Technology Department. Mrs. Buckles stated that she attended a community informational forum regarding teens using heroin, and the Every 15 Minutes program at Newbury Park High School.

Dr. Connolly asked if staff could give a report on the results of what schools Park Oaks' parents requested for their children for the 2011-2012 school year. Dr. Baarstad stated that Mr. Iezza was at Park Oaks the day after the closure announcement to talk to staff, and has been meeting with Mrs. Anna Alvarez regarding the Wednesday night outreach programs. Mrs. Cosaro stated that Weathersfield, Lang Ranch, Ladera and Glenwood principals offered day time and evening tours for families. So far, the (preliminary) numbers of Park Oaks students' requests at each school are: 77 Weathersfield, 72 Glenwood, 64 Ladera, 44 Lang Ranch, and 10 Acacia. Parent-pay transportation is being offered to students attending Glenwood Elementary only, as only that school qualifies under current District Policy. Dr. Stephens asked if the issue of transportation was clearly defined on the applications. Mrs. Cosaro stated yes, that information was available on all applications in English and Spanish.

The Board asked that all schools post this information on their websites and in their newsletters, especially the date of the first day of school. Motion carried 4-0.
