Mrs. Phelps moved to <u>approve revised Board Policy & Administrative Regulation 5144 – Discipline, as submitted, seconded by Mr. Andersen. Motion carried 5-0.</u>

E. Approval of Amendments to Board Policy and Administrative Regulation 5145.3: Nondiscrimination/Harassment

Mrs. Buckles moved to approve amendments to Board Policy and Administrative Regulation 5145.3: Nondiscrimination/Harassment, as submitted by staff, seconded by Mrs. Phelps. Three public speakers supported the amendments to the policy and regulation as submitted by staff. Six public speakers supported adding language to the policy that had been submitted by Mr. Dunn. Mr. Dunn moved to add the following amendment to Mrs. Buckles' motion: "The right to privacy of all students in the CVUSD shall not be violated or infringed. No student shall enter a bathroom occupied by another student of the opposite biological sex. No student shall enter a shower occupied by another student of the biological sex." The amendment was seconded by Mr. Andersen. Each Board member offered their opinion as to whether the policy and regulation needed to be further expanded in order to protect the right of privacy for all students and whether the language submitted by Mr. Dunn was consistent with the statutes and intent of Assembly Bill 1266. Mr. Dunn's amendment to the original motion was submitted for vote: motion failed 2-3 (Board members Dunn and Andersen voted Yes; Buckles, Connolly and Phelps voted No). The original motion carried 3-2 (Board members Buckles, Connolly, Phelps voted Yes; Andersen and Dunn voted No).

Mr. Dunn moved to <u>approve amendments to Board Policies 5147 – Dropout Prevention & 5149 – At-Risk Students</u>, as <u>submitted</u>, seconded by Mrs. Buckles. Motion carried 5-0.

She focused on the Math Progression Chart to show the avenues of choice families may consider as their students proceed through grade levels 5-12. Dr. Boone fielded questions from the Board. Ten public speaker cards were submitted. The great majority of speakers were District math teachers who were generally in support of the proposed progression.
