OPENING PROVISIONS

Call to Order and Roll Call: President Stephens called the meeting to order at 6:09 p.m. Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps and Dr. Timothy Stephens. Administration: Dr. Jeffrey L. Baarstad, Superintendent, Timothy Carpenter, Deputy Superintendent, Personnel Services and Linda Bekeny, Assistant Superintendent, Business Services. Other staff: Dr. Jeff Davis, Director, Secondary Education, Carol Boyan-Held, Director, Elementary Education and Dr. Jon Sand, Director, Curriculum and Assessment.

Dr. Stephens read the procedural announcements, led the pledge of allegiance and welcomed everyone to the meeting. There were no announcements from closed session.

Comments from the Superintendent

Dr. Baarstad congratulated and thanked the Classified Employees for their hard work and support. He announced that there will be a Common Core Forum held on Monday, June 10, at 6:00 p.m. at the Thousand Oaks High School Performing Arts Center. The moderator for the event will be Kyle Jorrey, Editor of the Acorn.

Comments from Individual Board Members

Dr. Connolly and Mrs. Phelps stated that they served as judges for the "We the People" program and praised the students and teachers for their excellent preparation for the program. Dr. Stephens congratulated Karen Buck, teacher at Wildwood Elementary School, who was honored as Teacher of the Year by the Chamber of Commerce. Dr. Stephens also announced the TUPE Grant that the District has received, which is funded by the tobacco taxes and provides cessation programs to teens who smoke.

Dr. Stephens announced the bid process. He accepted three sealed bids from 1) Daylight Investors, LLC, 2) RK Realty, LLC, and 3) Purvis Investments, LLC. Dr. Stephens handed the bids to Dr. Joel Kirschenstein, Sage Institute, the District's Property Negotiator, who proceeded into the adjoining conference room to review the bids with his legal advisor, Mr. Monte Widders, (law offices of Myers, Widders, Gibson, Jones & Feingold, LLP). Dr. Kirschenstein and Mr. Widders were available to the public if anyone had questions or wished to witness the bid process.

The process continued through the end of the Board's Agenda. At approximately 7:30 p.m., the Board adjourned while Dr. Kirschenstein and Mr. Widders continued their review of the bids. At approximately 7:40 p.m., the Board was informed that the initial review was complete and a Special Meeting was recommended to complete the bidding process.

Mrs. Phelps moved to <u>adjourn the meeting to May 28, 2013, at 4:00 p.m. to receive more information about the Kelley Road Surplus Property bids</u>, seconded by Dr. Connolly. (Please see the Adjournment section of the minutes.) Motion carried 5-0.

INFORMATION ITEMS

Instructional Services

A. CVUSD Outdoor Education – Status Report

Dr. Jeff Davis, Director, Secondary Education, and Middle School Principals Jason Branham, Los Cerritos, Josh Eby, Sycamore Canyon and Steve Lepire, Redwood, provided information about the current state of the sixth grade Outdoor Education Program. While the Outdoor Program experience has been a tradition in CVUSD for over 25 years, there are problems with rising costs due to many and a shift in the classroom curriculum that no longer syncs with the outdoor school. The increasing costs have encroached on the General Fund by approximately \$55,000 for the last few years. Dr. Davis and the principals have investigated an alternative program, Fulcrum Learning Systems, which includes outdoor learning combined with a strong emphasis on 21st Century Learning Skills that connect well to the new Common Core Standards. The Board asked many questions. Dr. Connolly stated her displeasure that there would be a shift from a science-based program to more of a pre-packaged product that lacks good value. Dr. Baarstad stated that there is both an academic and sociological benefit to the Fulcrum program, which offers exercises in communication, consensus building, critical thinking and character development in an outdoor environment for two days. He explained that the sixth grade core teachers and principals have stated their concerns about the outdoor school taking a lot of energy and time away from classroom instruction. The oard asked that Dr. Davis return at the June 4 Board meeting with a presentation on the Fulcrum Program along with cost comparisons for a one-day and two-day, one night program.
