# CONEJO VALLEY UNIFIED SCHOOL DISTRICT BOARD OF EDUCATION SPECIAL MEETING-DISCUSSION SESSION

### JULY 20, 2010 MINUTES

#### **MEETING**

The Conejo Valley Unified School District Board of Education met on Tuesday, July 20, 2010, at 1400 E. Janss Road, Thousand Oaks, CA, in the Board Room.

#### ROLL CALL

Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps, and Dr. Timothy Stephens. Superintendent Dr. Jeffrey Baarstad, Janet Cosaro, Assistant Superintendent, Instructional Services, and Tim Carpenter, Assistant Superintendent, Personnel Services, were also present.

## CALL TO ORDER AND PLEDGE

President Phelps called the Special Meeting to order at 2:32 p.m. She led the Pledge of Allegiance and read the procedural announcements.

## **PUBLIC COMMENTS**

There were two public speakers who expressed their concern that neighbors did not have advance information about the project and the impact of the bike lane to homeowners on El Monte. They also expressed concern about the proposed Two Moons Concert at Conejo Creek (CVUSD has no information about this concert).

# ACTION ITEM: APPROVAL OF EASEMENT AGREEMENTS WITH THE CITY OF THOUSAND OAKS FOR PAIGE LANE BIKE PATH

Dr. Connolly moved to approve easement agreements with the City of Thousand Oaks to allow construction of a bicycle/pedestrian path on the District's vacant Janss Road property immediately adjacent to Paige Lane, seconded by Mr. Dunn. Motion carried 5-0.

# INFORMATION/DISCUSSION ITEM: 2010-2011 BOARD/DISTRICT GOALS

The Board met to discuss concepts and the content of their core beliefs, vision, and priorities.
