Also present were Robert Iezza, Director, Elementary Education, Dr. Jeff Davis, Director, Secondary Education, Dr. Margaret Saleh, Director, Special Education, and Marina Mihalevsky, Director, Classified Personnel

Mrs. Phelps led the Pledge of Allegiance and asked for a moment of silence to honor one of Westlake High School's graduates and heroes, A.J. Castro, whose life was taken during his service to our country in Afghanistan.

The second annual Walk for Healthy Schools will be on Saturday, September 25, with registration beginning at 8:00 a.m., and the Walk at 9:00 a.m.

Conejo Council PTA President, Wendy Laufer, reported on the summer training events for the Executive Board and returning Presidents and Treasurers to help focus on the basics of PTA. During the year, leaders will meet and network with others throughout the district. PTA is asking community members to contact the governor and local legislators requesting that they pass a budget that protects education and other children's services.

Comments from the Superintendent

Dr. Baarstad reported that the District had a very successful opening on September 1, and that due to an adjustment in the budget, staff was happy to reinstate the teacher prep day – which certainly contributed to the smooth opening. He was pleased to announced that the enrollment looks good with strong numbers in kindergarten classes. The State issued information on the Academic Performance Index (API). Overall the District is up by 9 points. More information will be available once the state releases the embargo on the scores. Dr. Baarstad discussed his attendance at the Newbury Park High School vs. Buena High School football game and how much he enjoyed watching the halftime activities – on and off the field!

Dr. Baarstad offered information about the Conejo's fallen hero, A.J. Castro, who has been recommended for a Citation. He announced that a memorial will be given at the Westlake High School football game on Friday, September 10, for A.J. and Frankie Toner, who also lost his life in service to our country last year. Dr. Baarstad, on behalf of the Board and the District, sent condolences to the families.

Board of Education and Superintendent

- A. Adjust Board Meeting Calendar Due to Conflicts: The Board discussed options for November 2 (Election Day) and December 21 (during Winter Recess). It was decided that for November 2, the time for Closed Session would begin at 4:30 p.m., Open Session at 5:00 p.m. and the Board requests that no presentations be scheduled for that meeting. For December 21, the date of the board meeting would be changed to December 14. Staff will prepare an agenda report for action at the September 7 Board meeting.
- B. Parcel Tax Information: Dr. Baarstad presented several options to the Board for a possible parcel tax election. Copies of this report may be obtained through the Superintendent's office (805-497-9511, extension 201). It is projected that the 2011-2012 school year will be operating with (approximately) \$8 million less than projected expenses, and therefore, more drastic cuts will have to occur that may cut into programs and class size. The Board asked Dr. Baarstad many questions such as possible local sales tax, state budget expectations, future cuts, and sale of surplus property. There will be a study session on September 7 regarding surplus property.
