# CALL TO ORDER – CLOSED SESSION

The Board meeting of August 18, 2009, was called to order by President Timothy Stephens at 3:30 p.m. at 1400 E. Janss Road, Thousand Oaks, CA. The Board and Superintendent discussed alignment of the Board's goals with the Strategic Plan. Copies of this report may be obtained through the superintendent's office.

The Discussion Session ended at 6:05 p.m., and the Board convened to Open Session Regular Meeting.

# CALL TO ORDER - REGULAR MEETING

Dr. Stephens called the meeting to order at 6:12 p.m.

Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps, and Dr. Timothy Stephens. Administration: Mario V. Contini, Superintendent, Dr. Jeffrey Baarstad, Deputy Superintendent, Timothy Carpenter, Assistant Superintendent, Personnel Services, and Janet Cosaro, Assistant Superintendent, Instructional Services. Also in attendance were Carol Boyan, Director, Curriculum, Jeff Davis, Director, Secondary Education, Robert Iezza, Director, Elementary Education, and Pete Peterson, Director, Planning & Facilities.

Dr. Stephens acknowledged the Boy Scout Patrol from Troop 787, who was working on their citizenship and community badges. The Patrol led the Pledge of Allegiance.

## **OPENING PROVISIONS**

## Approval of the Agenda

Mrs. Phelps moved to approve the Agenda, seconded by Mrs. Buckles. Motion carried 5-0.

## **Comments from the Superintendent**

Mr. Contini greeted Mr. Carpenter as the new Assistant Superintendent, Personnel Services, on the dais. He also 1) welcomed everyone back to school on August 27; 2) discussed important work accomplished over the summer by all departments to ensure a smooth opening of school and complimented many key players including custodians and office staff, maintenance, warehouse, and grounds staff, principals and administrators; 3) announced that the Public Relations Committee recommended that the district eliminate the "High Expectations  $\rightarrow$  High Achievement" motto and consider replacing it with something more current and relevant, which they will be working on; 4) announced the EARThS ribbon cutting and school opening on Thursday, August 27 at 8:00 a.m. EARThS is the district's second magnet school. Mr. Contini applauded Principal Jennifer Boone and the entire team of teachers and parents who have accomplished amazing things to open EARTHS next Thursday. 5) congratulated Dr. Linda Calvin, Sue McCormick, and Jerry Leavitt for working on and being awarded a \$650,000 grant over three years for Tobacco Use Prevention Education (TUPE); 6) also congratulated Leigh Ann Diffenderfer, Home Economic Career and Technology Teacher at Newbury Park High School for the good things that happened over the summer in her department: she received the Dream, Dare, Do award by the Home Economics Teachers Association of California at the State Leadership and Management Conference in Sacramento, and (former) student Tiffany Hernandez received a silver medal culinary arts award at the Family, Career and Community Leaders of America national conference. 7) mentioned the great stress on staff over the next couple of years due to the budget, but thanked everyone for their commitment to continue to do what's best for students. 8) and was happy to announce that most all of our teachers who received layoff notices in the spring have been re-hired at the district (as of this writing, 100% were offered jobs; six declined).

Mr. Dunn asked about the State's efforts to balance budget by taking 20% of redevelopment funds. Dr. Baarstad stated that at this time there is no approval for this plan.
