# **OPENING PROVISIONS**

Call to Order and Roll Call: President Stephens called the meeting to order at 6:00 p.m. Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps and Dr. Timothy Stephens. Administration: Dr. Jeffrey Baarstad, Superintendent, Robert Iezza, Assistant Superintendent, Instructional Services, Linda Bekeny, Assistant Superintendent, Business Services, and Mark McLaughlin, Assistant Superintendent, Personnel Services. Dr. Jeff Davis, Director, Secondary Education, Dr. Jon Sand, Director, Curriculum and Assessment, Marina

Mihalevsky, Director, Classified Personnel, and Mike Buckley, Director, Maintenance & Operations, were also present.

Dr. Stephens read the procedural announcements and welcomed everyone to the meeting.

Mrs. Phelps moved to approve the agenda, seconded by Mrs. Buckles. Motion carried 5-0.

Dr. Baarstad told the Board that Dr. Sand will be providing a report to them at the September 17, 2013, meeting regarding the test scores. He proudly announced that CVUSD's test scores are up for the fourth year in a row!

## **Comments from Individual Board Members**

Dr. Stephens thanked Mark McLaughlin for the successful New Teachers meeting at the Conejo Recreation & Parks District venue. He also discussed his visit to the Staff Development event that occurred at EARTHs for 4-5 grade teachers. He stated it was with filled with information that was valuable for the teachers. He is also very pleased that the District is sending some teachers to intensive training in Common Core and assessment, so they bring their knowledge back to the District to train other teachers. Dr. Stephens commended Dr. Sand, Robert Iezza, and Carol-Boyan Held for their leadership in this area.

Mrs. Buckles moved to <u>adopt Administrative Regulation 4117.14</u>, 4317.14: <u>Postretirement Employment</u>, seconded by Mrs. Phelps. Motion carried 5-0.

# D. Neighborhood for Learning - Reorganization and Establishment of Position

Mrs. Phelps moved to approve the establishment and/or modification of classified assignments as specified, seconded by Mrs. Buckles. One public speaker spoke against the reorganization/layoffs. Motion carried 4-1 (Dunn voted nay).

# E. Approve Resolution #13/14-02: Layoff

Mrs. Phelps moved to approve the establishment of classified assignments as specified, seconded by Dr. Connolly. There were three public speakers against the reorganization and layoffs. Mr. Dunn had several questions about the need for a reorganization which included the layoffs of three part-time positions and the creation of one full-time position. He asked several questions about salaries, supervisory positions, and oversight of the program. Dr. Baarstad explained that the new services known as Triple-P (Positive Parenting Program) is the reason for some changes in the organizational structure. Mr. Dunn asked why positions are being laid off when the program received approximately \$95,000 additional money this year. Mr. McLaughlin explained that on June 18 the Board approved the appointment of two NfL positions, at the cost of \$70,000, which is being funded by the additional money. Mr. Dunn asked if NfL received insufficient funds to pay their expenses, can we reimburse them with unrestricted General Funds. Dr. Baarstad responded yes, but that is why staff monitors the program carefully. Motion carried 4-1 (Dunn voted nay)

### F. Establishment of Classified Position

Mrs. Buckles moved to approve the establishment and/or modification of classified assignments as specified, seconded by Mr. Dunn. Motion carried 5-0.
