DISCUSSION SESSION

OPENING PROVISIONS

Call to Order and Roll Call: President Stephens called the meeting to order at 6:10 p.m. Present were Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps and Dr. Timothy Stephens. Administration: Dr. Jeffrey Baarstad, Superintendent, Robert Iezza, Assistant Superintendent, Instructional Services, Linda Bekeny, Assistant Superintendent, Business Services, and Mark McLaughlin, Assistant Superintendent, Personnel Services. Dr. Jeff Davis, Director, Secondary Education, Carol Boyan-Held, Director, Elementary Education, Dr. Jon Sand, Director, Curriculum & Assessment, and David Fateh, Director, Facilities & Construction, were also present.

Dr. Stephens read the procedural announcements and welcomed everyone to the meeting.

Mr. Iezza and Dr. Sand presented this year's Focus Areas and Professional Development Plan. Dr. Stephens stated that in all his years in education he had never seen a more comprehensive staff development plan. Mike Soules, President, Conejo Schools Foundation, distributed a book published by Corwin Press by a former CVUSD student, Zak Kukoff, "The Autism Ambassadors Handbook." He stated that Summer School was a huge success again this year, with an enrollment of 768 students. Mr. Soules announced the success of the *Walk for Healthy Schools* event, and thanked the CVUSD Wellness Committee for their outreach and promotion. Mr. Soules stated that this year is the 10th anniversary of the Conejo Schools Foundation, and that the Foundation will be focusing on the following priorities: Arts and Enrichment, College and Career Readiness and 21st Century Skills, Classroom Grants, and Naming Opportunities.
