CALL TO ORDER - REGULAR MEETING

Dr. Stephens called the meeting to order at 6:10 p.m.

Also in attendance were Carol Boyan-Held, Director, Curriculum, Jeff Davis, Director, Secondary Education, Robert Iezza, Director, Elementary Education, Pete Peterson, Director, Planning & Facilities, Marina Mihalevsky, Director, Classified Personnel and Jerome Staszewski, Director, Technology.

Dr. Stephens led the Pledge of Allegiance and read the procedural announcements.

Dr. Stephens announced that during Closed Session, under Government Code §54957, the Board heard from Pat Phelps and him regarding their review of options available to the Board in filling the future vacancy of superintendent. After a couple of months of deliberation and careful consideration of information that Dr.

Stephens and Mrs. Phelps gathered through interviews with representatives of teachers, classified personnel, counselors, administrators, PTA, DAC, the Board is very pleased to announce that by unanimous vote it has decided to appoint Dr. Jeffrey Baarstad as the next superintendent of the Conejo Valley Unified School District, effective July 1, 2010.

Dr. Baarstad thanked the board for their trust in him, and stated how much he has enjoyed working with the teachers, staff, students and board.

Dr. Stephens thanked Mr. Contini for guiding the board through the process. Mr. Contini stated that he is thrilled that the board has appointed Dr. Baarstad.

Comments from the Superintendent

Mr. Contini apologized to parents and community members who have had difficulty getting through to the district by telephone and/or email. The district will be upgrading the server in the future, and Verizon has been called to repair the phones, but parts are on order. One system has nothing to do with the other, but unfortunately, both are causing frustration.

Mr. Contini congratulated the Westlake High School's Junior State of America Club for receiving the 2009 National Civic Impact Award from the Junior Statesmen Foundation for being the chapter that has had the biggest impact on increasing the level of civic awareness and engagement in a school. Student Adam Raudonis is the President of the Club, and Jim Azevedo is the teacher/advisor. The club will receive \$2,500.

One speaker spoke in favor of preserving the Outdoor School Program, one spoke in support of military recruiters on campuses, four speakers spoke in favor of keeping the woodshop programs at the middle school level.
