Members

from the audience were invited to offer their suggestions and concerns. Dr. Connolly acknowledged that there are many different needs to meet and that the task of developing the school year calendar is challenging, and stated the Board's appreciation to all those involved. OPENING PROVISIONS

Dr. Baarstad ended with an announcement of the event naming the Newbury Park High School football field the George Hurley Field, honoring retired coach and teacher, George Hurley. The event will occur prior to the football game October 19.

Mrs. Buckles discussed attending The Sounds of The Conejo band event and football games. Mrs. Buckles mentioned a website, www.donorschoose.com, which allows individuals to donate to individual classrooms. She encouraged teachers to sign on to the website so that individuals may contribute to their classrooms. Dr. Connolly commended the committee that worked on the Thousand Oaks High School's 50th Anniversary event.

E. Resolution #12/13-10: Authorize the Issuance of Conejo Valley Unified School District 2012 General Obligation Refunding Bonds

Mrs. Buckles moved to approve Resolution #12/13-10 using the Savings in Targeted Years option, seconded by Dr. Stephens. Dr. Baarstad reminded the Board about the presentation at the October 2 Board meeting from Tim Carty, representative from Piper Jaffray, bond underwriter, regarding refinancing the remainder of the Measure R bonds at today's much lower interest rates, saving the tax payers around \$1.5 million. The Board asked staff to return with documents relating to the refinancing. Bond council, David Casnocha, was available to answer questions from the Board, confirming that the refunding of the bonds will save the taxpayers money and that the maturity of the bonds will not be extended. Motion carried 5-0.
