## CONEJO VALLEY UNIFIED SCHOOL DISTRICT **BOARD OF EDUCATION REGULAR MEETING**

## October 28, 2003 MINUTES (Unadopted)

The Conejo Valley Unified School District Board of Education met in Regular Session on October 28, 2003, at the District Office Board Room, 1400 East Janss Road, Thousand Oaks, California.

CALL TO **ORDER** 

Present were Board members Dorothy L. Beaubien, Mary Jo Del Campo, Dolores Didio, Patricia H. Phelps, and Timothy G. Stephens. Also present were Robert Fraisse, Superintendent, Richard Simpson, Assistant Superintendent, Instructional Services, Jody Dunlap, Assistant Superintendent, Personnel Services and Gary Mortimer, Assistant Superintendent, Business Services. Chuck Eklund, Director, Secondary Education and Martha Mutz, Director, Curriculum/Media Services were also in attendance.

**ROLL CALL** 

The Closed Session meeting was called to order at 5:00 p.m. by Dolores Didio, President. The Board discussed appointment/employment of: Certificated: Teachers, Administrators; Classified: Child Care Assistants, Child Nutrition Assistants, Family Resource Specialist/Bilingual Spanish, Paraprofessionals/Special Ed, Site Computer Technician, Substitutes; Exempt: Specialists, Campus Supervisors, Student Helpers, Athletic Coaches. The Closed Session ended at 5:55 p.m.

**CLOSED SESSION** 

President Didio called the meeting to order at 6:08 p.m., led the Pledge of Allegiance, and read announcements for the Board meeting that reviewed instructions regarding smoking, cell phones, Speaker's Cards, Public Statement Cards, and where the public can find agendas and Board procedure information.

**PLEDGE AND** ANNOUNCE-**MENTS** 

Mrs. Beaubien moved to approve the agenda, seconded by Dr. Stephens. Motion APPROVE carried 5-0.

**AGENDA** 

Dr. Fraisse introduced Debra Bergman, Manager, Education Relations from The RECOG. Boeing Company, and thanked Boeing for their \$10,000 technology grant, which will be applied toward the SuccessMaker program at elementary schools.

Keri Bowers, representing PAUSE4kids, an advocacy organization for special needs children, thanked Jack Bannon, Associate Director, Special Education, for his collaborative efforts to build a partnership with them.

Dr. Fraisse 1) expressed concern for the firefighters and families affected by the SUPT. current fires across Southern California. He assured our parents that the District REMARKS makes very careful decisions when to close schools, and that we are in contact with the County offices and health department daily. We also respect parents' decision to keep students home when they believe that this decision is in their child's best interest; 2) stated that the Boys & Girls Club building is in place at Los Cerritos, and should

open its doors in December; 3) announced that there will be only one Board meeting in November on the 18th; 4) thanked Wells Fargo for sponsoring the recent School Views, which has just been distributed; 5) congratulated students and staff at Westlake High School on their 25th year celebration and homecoming game last week; 6) commended Aspen Elementary for their great celebration for Red Ribbon Week; and 7) applauded the opening of the new girls' softball field at Thousand Oaks High School.

SUPT. **REMARKS** (CONT.)

Suzanne Duckett, Thousand Oaks, thanked members of the Conejo Valley Historical PUBLIC Society for backing the preservation of Timber School (currently Conejo Valley High **COMMENTS** School administrative offices).

Dr. Stephens thanked the staff for working toward the successful restoration of one of **BOARD** the Beginning Teachers Support and Assessment (BTSA) teachers, and commented on **REMARKS** the excellence and importance of the program.

Mrs. Didio discussed her attempt earlier in the year to reestablish an intergovernmental liaison committee with the City of Thousand Oaks and the Park District, to be made up of two elected officials and staff from each agency. Mrs. Didio feels that it would be appropriate for this committee to address the designation of the administrative offices of Conejo Valley High School as a historical building. This issue has been publicly addressed; however, as owners of the site the School District has not been contacted. Mrs. Didio is anxious to have the committee meet to address this issue as well as other issues of common interest to the three agencies that could benefit the entire community.
