Dr. Stephens also discussed touring the Wellness Center at the Adult School. He was greatly impressed by the facility, which is expected to

expand. In addition to operating as a clinic, the program trains students to be prepared for health-related jobs in the community. Mrs. Phelps discussed touring Banyan Elementary School with Mrs. Buckles and Principal Laurie Davis. She was impressed that there is a Smart Board in every classroom. Mrs. Buckles also discussed her visit to Lang Ranch Elementary School and the various technology available to students.
