CALL TO ORDER - CLOSED SESSION

The Board meeting of Tuesday, November 15, 2011, was called to order by President Peggy Buckles at 5:00 p.m. at 1400 E. Janss Road, Thousand Oaks, CA. Mrs. Buckles asked if there were any public speakers for the Closed Session agenda items; there were none. The Board adjourned into Closed Session at 5:03 p.m., where the following items were discussed:

REGULAR SESSION

OPENING PROVISIONS

Call to Order and Roll Call: Mrs. Buckles called the meeting to order at 6:12 p.m. Present were Board members Peggy Buckles, Dr. Betsy Connolly, Pat Phelps and Dr. Timothy Stephens. Mike Dunn was not present. Administration: Dr. Jeffrey Baarstad, Superintendent, Timothy Carpenter, Assistant Superintendent, Personnel Services, and Linda Bekeny, Assistant Superintendent, Business Services. Also present were Dr. Jeff Davis, Director, Secondary Education and Jack Wilson, Director, Facilities and Construction.

Mrs. Buckles read the procedural announcements and welcomed everyone to the meeting.

Approval of the Agenda

Mrs. Phelps moved to approve the Agenda, seconded by Dr. Stephens. Motion carried 4-0.

Report: Conejo Valley High School, Martin Manzer, Principal

Mr. Manzer introduced his staff present in the audience and provided a report which outlined the educational programs and support offered to the students that attend Conejo Valley High School.

Comments from the Superintendent

Dr. Baarstad 1) reported that the sale of the property located at Avenida de los Property is still in progress and he should be able to provide a report at the December 6 Board meeting. 2) announced the TedX Youth Event that will be held this Sunday, November 20, in the Westlake High School Performing Arts Center. This event is completely planned and performed by students. Please contact http://tedxyouthconejo.com for more information. 3) commended Mr. Manzer, staff and students at Conejo Valley High School for the tremendous feedback received from the Model Continuation School visitation team last week. 4) applauded the successful sport season across the district, with Marmonte League championships in many areas: football, girls' volleyball, boy's water polo, cross county, girl's tennis and girl's golf. 5) proudly announced the successful marching band season, with many awards at local events and festivals.

Comments from the Public

One speaker spoke about her opposition to the building of the Community Learning Center. One speaker offered an alternative plan to the present one regarding the sale of one property to purchase another for the relocation of the Maintenance & Operations facility.

Comments from Individual Board Members

Dr. Connolly announced an event scheduled for November 29, 4:00 p.m., at the Ventura County Office of Education, "Ventura County Schools...Making the Grade," where Tom Torlakson, California State Superintendent of Schools, will also speak.

Mrs. Buckles would like to have a resolution sent from Senator S. Joseph Simitian's office allowing school districts, community college districts, and county offices of education to pass a parcel tax with a 55 percent majority vote rather than the currently required two-thirds.

Superintendent

A. Acceptance of Proposal for Purchase of Conejo Center Drive Surplus Property

Dr. Baarstad reviewed protocols for the process of opening and processing the bids submitted. He announced that the District received two proposals for the purchase of the Conejo Center Drive surplus property, which he opened at the dais. Mrs. Buckles announced that one bid was from Ponte Road Properties LLC, and one from FritzCo Real Estate.

At 7:25 p.m., Dr. Baarstad announced that Dr. Joel Kirschenstein, the District's property negotiator, Irma Tucker of Sage Institute and Monte Widders, legal counsel, will review the bids to ensure that they are conforming bids. (Dr. Kirschenstein, Mr. Widders and Ms. Tucker remained in the Board Room during their review of the bids.)

At 8:01 p.m., Dr. Kirschenstein announced that the proposal received from Ponte Road Properties LLC appears to be a conforming bid, and that counsel would be ready to brief the Board in Closed Session. The Board adjourned into Closed Session to discuss the contents of the bid from Ponte Road Properties LLC with counsel.

At 8:28 p.m., the Board reconvened into Open Session where the following announcement was made by Mrs. Buckles: Due to the complexity of the transaction and the need for consulting staff to clarify the terms and conditions of the RFP received, she would like a motion to be made to carry the issue forward for decision on an adjourned session of this meeting to be held on November 22, 2011, at 4:00 p.m.

Mrs. Phelps moved to <u>carry the issue forward for decision at an adjourned session of this meeting to be held on November 22, 2011, at 4:00 p.m.</u>, seconded by Dr. Stephens. Motion carried 4-0.

B. Approval of Agreement for the Purchase of the Mitchell Road Property

Dr. Stephens moved to approve the Standard Offer, Agreement and Escrow Instructions for Purchase of Real Estate with SDG Mitchell Associates LLC, as submitted, and authorize the Superintendent to sign all agreements, seconded by Dr. Connolly. Mrs. Phelps responded to one speaker's suggestion by saying that this purchase is essential to complete all the transactions necessary for the relocation of Maintenance & Operations. Dr. Baarstad confirmed. Motion carried 4-0.
