Dr. Jeff Davis, Director, Secondary Education and Dr. Jon Sand, Director, Curriculum and Assessment.

Dr. Connolly read the procedural announcements and welcomed everyone to the meeting.

Mrs. Buckles congratulated Mary Maki, coordinator of the Conejo Council PTA Reflections program, for an excellent Reflections evening celebrating the various talents of our students. Ms. Buckles visited the Power Program at the Adult School and was impressed with the diligence of the students to work toward their high school degree. Mrs. Buckles discussed her attendance at the California School Boards Association (CSBA) Conference and requested a Discussion Session to debrief from the conference. Mrs. Phelps, Dr. Stephens and Dr. Connolly concurred with Mrs. Buckles regarding the Reflections Program and the CSBA Conference. Dr. Connolly also congratulated the Thousand Oaks High School band and commended the district's continued commitment to the arts programs. The Board directed the Superintendent to schedule a discussion session to debrief information obtained at the CSBA conference on January 15, 2013, at 5:00 p.m.

C. Approval of School-Wide Title 1 Funding Model

Mrs. Phelps moved to <u>approve the School-Wide Title I funding model</u>, seconded by Mr. Dunn. Motion carried 5-0.

D. Approval of English Language Arts Instructional Materials – Grades TK-5

Dr. Stephens moved to <u>adopt and purchase the instructional materials as recommended by the Elementary English</u> <u>Language Arts Committee</u>, seconded by Mrs. Phelps. Mrs. Buckles and Mr. Dunn had a few clarification questions which were answered by Dr. Jon Sand, Director, Curriculum and Assessment, and one from Mr. Dunn by a Kindergarten teacher, Carrie Sonstegard. Dr. Connolly inquired about the timing of the implementation of Common Core curriculum and the purchase of the adoption at this time – will we require more updated Common Core materials before the adoption ends (in 2019). Dr. Sand assured the Board that the proposed adoption of the "Treasures" curriculum includes Common Core support and resources until such time the State recommends otherwise. Treasures also includes bridge materials for Common Core and the Smarter Balance assessments, which is a main concern of staff as the new assessments are still being developed. Dr. Stephens stated his desire that every school implement teaching practices that are aligned with the adoption by having a teacher-coach at each school working in concert with the principal to model and maintain a high level of teaching standards. Motion carried 5-0.
