DECEMBER 17, 2013 <u>MINUTES</u>

<u>SPECIAL MEETING – DISCUSSION SESSION</u>

At 4:03 p.m., Dr. Stephens called the Special Meeting – Discussion Session to order. Board members Peggy Buckles, Dr. Betsy Connolly, Mike Dunn, Pat Phelps and Dr. Timothy Stephens were present. Administration present: Dr. Jeffrey Baarstad, Superintendent, Robert Iezza, Assistant Superintendent, Instructional Services, Linda Bekeny, Assistant Superintendent, Business Services, and Mark McLaughlin, Assistant Superintendent, Personnel Services. Carol Boyan-Held, Director, Elementary Education and Dr. Jon Sand, Director, Curriculum & Assessment, were also in the audience.

Dr. Stephens asked if there were any public speakers for the Discussion Session; there were none.

Board Members were asked to share information from sessions they found particularly useful or important at the California School Boards Association (CSBA) Annual Conference and Trade Show.

- Mrs. Buckles discussed the Quest Academy, a program for at-risk middle school students in La Mesa Spring Valley School District, and a teacher run summer program, Making Summer Matter, which helped bridge the achievement gap and summer learning/loss that students experience.
- Mrs. Phelps mentioned the School Facilities to Support Common Core and 21st Century Learning workshop, where the importance of school facility design and furniture (flexibility and mobility) was emphasized. Mrs. Phelps also discussed the Quest Academy, and seminars on Saturday School and Student Board Representatives.
- Dr. Stephens talked about the workshop he attended on Parcel Taxes and Bonds.
- Dr. Connolly discussed the "Reclaiming Senior Year" program that she attended, hosted by Santa Monica Unified School District. This program is designed for the students who opt out of mathematics in their senior year. Dr. Connolly was also impressed by the "Closing the Achievement Gap Digital Style" and "Teachers Leadership Academy" sessions.

The Special Meeting-Discussion Session ended at 4:55 p.m., and the Board adjourned into Closed Session.
