# CALL TO ORDER – OPEN SESSION

### **OPENING PROVISIONS**

President Didio called the meeting to order at 6:13 p.m., led the Pledge of Allegiance, and read the procedural announcements for the meeting.

Present were Board members Dorothy Beaubien, Dolores Didio, Mike Dunn, Pat Phelps, and Dr. Timothy Stephens. Administration: Mario V. Contini, Superintendent, Dr. Jeffrey Baarstad, Deputy Superintendent, Jo-Ann Yoos, Assistant Superintendent, Personnel Services, and Janet Cosaro, Assistant Superintendent, Instructional Services. Max Beaman, Director, Secondary Education and Carol Boyan, Director, Curriculum, were also present.

### **Reorganization of the Board of Education**

Mrs. Didio handed the gavel to Mr. Contini to begin the nominations for officers of the Board. Mr. Contini asked for nominations for the office of President of the Board. Dr. Stephens moved to nominate Dorothy Beaubien for the office of President of the Board, motion carried 5-0.

Mr. Contini handed the gavel to new President Beaubien, who thanked Mrs. Didio for her excellent year of leadership, and then proceeded with the nominations.

Mrs. Beaubien asked for nominations for the office of Vice President. Mrs. Phelps moved to <u>nominate</u> <u>Dr. Stephens for the office of Vice President</u>, motion carried 5-0.

Mrs. Beaubien asked for nominations for the office of Clerk of the Board. Mrs. Didio moved to nominate Mrs. Phelps for the office of Clerk of the Board, motion carried 5-0.

Mrs. Beaubien asked for appointment of a Board Representative to the Ventura County Committee on School District Organization. Dr. Stephens moved to <u>nominate Pat Phelps to serve as the Board</u> <u>Representative to the Ventura County Committee on School District Organization</u>, motion carried 5-0.

Mrs. Beaubien asked for a nomination regarding the date, time and place of regular meetings. Mrs. Phelps <u>moved to continue the meetings to the first and third Tuesday of each month</u>. Dr. Stephens seconded the motion. Motion carried 5-0.

Mrs. Beaubien stated that, "The committee assignments for the upcoming year will be filled by appointment formally at our next Board meeting of January 8, 2008. Board members will be assigned to their current committees for purposes of continuity for the upcoming year unless it is brought to my attention that a Board member wishes to have another committee assignment."

Mrs. Beaubien again thanked Mrs. Didio for her year as President, and her continued service on the board. Dr. Stephens added that the position of President of the Board is a difficult position, and Mrs. Didio put in many hours over and above in service to the District. Mrs. Phelps and Mr. Dunn also thanked Mrs. Didio for her service.

Dr. Jeffrey Baarstad presented information regarding the secondary criteria. He stated that on January 15, 2008, a Study Session will be held to reveal the results of the blind scoring by the Facilities Committee.
