A. Board of Education – Update and Consideration of School Board Member Assignments to Committees

Trustee Sylvester made the motion to approve, seconded by Trustee Gill. There was no discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

B. Human Resources – Adoption of Resolution #23/24-20: National School Counseling Week – February 5-9, 2024

Trustee Gorback made the motion to approve, seconded by Trustee Powell. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

C. Student Services – Adoption of Resolution #23/24-19 in Recognition of the Lunar New Year Trustee Gill made the motion to approve, seconded by Trustee Gorback. There was no discussion on this agenda item. Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.

D. Business Services - 2022-2023 Financial Audit for Bond Measure I

Trustee Sylvester made the motion to approve, seconded by Trustee Powell. Dr. Hayek confirmed that there were no findings in the 2022-2023 Financial Audit for Bond Measure I and that the Bond Committee had reviewed the audit prior to its placement on the agenda for Board approval. Dr. Hayek responded to a Board member's question regarding the district's experience with a new audit firm. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

B. Board of Education - Approval of Amendments to Board Bylaw 9124 - Attorney

Trustee Gorback made the motion to approve, seconded by Trustee Gill. The Board discussed proposed revisions to codify language regarding the requirement of an affirmative Board majority vote for individual Board members who request to seek advice from legal counsel. Board members reached consensus to codify the language as discussed. *Trustee Gorback amended his motion and moved to accept the approval of the amendments to Board Bylaw 9124 – Attorney, seconded by Trustee Gill. Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.*

Trustee Gorback made the motion to approve the Consent Agenda as amended, seconded by Trustee Powell. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Kahl.**

5. INFORMATION/DISCUSSION ITEMS - GENERAL

A. Instructional Services - Presentation: WASC Report from Westlake High School

Principal Jason Branham and Dr. Laurie Looker presented information on the WASC report from Westlake High School, which included a brief description of the WASC process, WASC Self Study focus areas, WASC group leaders and meeting groups, schoolwide strengths, growth areas for continuous improvement, and next steps. Mr. Branham and Dr. Looker responded to questions from Board members regarding notable surprises on areas of strength or growth in the report, plans to present WASC report information to students, mention of school's competitive nature in the report, and future conversations on the connection between mastery grading and understanding academic relevancy.

B. Instructional Services – Presentation: International Baccalaureate TK-12

Principals Karla DiDomizio, Steve Lepire, and Michele McDonald presented information on the International Baccalaureate TK-12 program, which included background on the IB Programme continuum of learning and central elements, Cypress Primary Years Programme (PYP – grades 4 and 5) definition, highlights, and next steps; Sequoia Middle Years Programme (MYP – grades 6-8) timeline, professional learning, program benefits, key takeaways, and teacher feedback; and Newbury Park High IB Diploma Programme (grades 11 and 12) goals, participation options, and student feedback. Principals Judd, Lepire, and McDonald responded to questions from Board members regarding thoughts on offering these programs at all three grade levels, program connection challenges for ninth and tenth grade students prior to IB Diploma Programme participation, breakdown of eight subject areas in the MYP, challenges in the MYP implementation process, inclusion opportunities for special education students, IB Diploma Programme credit and course requirements, and access to global mindedness concepts for students not participating in the IB programme.

C. Instructional Services – Approval of New Middle School Core Literature Title – Almost American Girl

Mr. Loo provided background on the core literature approval process for this title. Board members commented on their appreciation for the expanded core literature offerings.

D. Instructional Services – Approval of New High School Core Literature Titles – Overground Railroad and Piranesi

Mr. Loo provided background on the core literature approval process for these titles and confirmed that *Piranesi* is a mythical text and would not be added to the optional required reading list for that reason. There was no Board discussion on this agenda item.

E. Superintendent – Approval of Amendments to Board Policy 1150 – Commendations and Awards

Dr. McLaughlin provided background on the language amendments specified by Gamut regarding types of commendations and awards that may be presented by the Board of Education. There was no Board discussion on this agenda item.

F. Superintendent – Approval of Amendments to Board Policy and Administrative Regulation 1340 – Access to District Records

Dr. McLaughlin provided background on the language amendments specified by Gamut regarding new law (AB1819), which allows members of the public to use their own equipment on district premises to copy or reproduce disclosable district records and updates the list of confidential public records to include the prohibition against the releasing of an employee's personal email address upon request from the employee. This amendment also notes that Board members can submit a Public Records Request (PRA). Dr. McLaughlin responded to a Board member's question regarding whether information responding to an individual Board member's PRA would be provided to all Board members.

G. Instructional Services – Approval of Amendments to Board Policy and Administrative Regulation 1312.3 – Uniform Complaint Procedures

Mr. Loo provided background on the language amendments specified by Gamut and aligned with Assembly Bill 1078, which adds that complaints regarding discrimination would be handled through the Uniform Complaint Process. Mr. Loo responded to a Board member's statement regarding the potential for appropriate remedies offered to support victims for complaints involving retaliation or unlawful discrimination, harassment, intimidation, or bullying being seen as punitive to the victim.

H. Instructional Services – Approval of Amendments to Administrative Regulation 1312.4 – Williams Uniform Complaint Procedures

Mr. Loo provided background on the language amendments specified by Gamut and aligned with Assembly Bill 1078, which provides the State Superintendent the authority to investigate and intervene on complaints regarding supplemental materials. There was no Board discussion on this agenda item.

I. Student Services - Approval of Amendments to Board Policy 5145.6 - Parent Guardian Notifications

Dr. Egans provided background on the language amendments specified by GAMUT regarding the requirement for districts to develop a plan to meet alternative formatting requirements for individuals with disabilities to ensure they can effectively participate in any program, service, or activity as required by law. There was no Board discussion on this agenda item.

J. Student Services – Approval of Amendments to Board Policy 6159.2 – Nonpublic, Nonsectarian School and Agency Services for Special Education

Dr. Egans provided background on the language amendments specified by GAMUT regarding the use of seclusion and restraint as it relates to a free appropriate public education for students with disabilities placed in nonpublic schools. Dr. Egans responded to a Board member's question regarding whether we would contract with nonpublic schools that follow procedures for seclusion and restraint that differ from district procedures.
