### 5. INFORMATION/DISCUSSION ITEMS - GENERAL

### A. Instructional Services - Presentation: WASC Reports from CVHS and TOHS

Mr. Loo provided background on the WASC accreditation process and criteria and introduced Mr. Manzer and Dr. Bergmann, who presented information on the recent WASC accreditation visits to their school sites. Their presentation encompassed information from their respective WASC committee final reports, including each site's areas of strength, areas of growth, highlights from the final report, an overall report summary, and next steps. Mr. Manzer and Dr. Bergmann responded to questions from Board members regarding student and parent input during the WASC visit, social emotional learning curriculum improvements, most challenging feedback topics to address, SDAC involvement during SPSA meetings, and professional learning related to Thousand Oaks University.

#### B. Instructional Services - Presentation: Elementary Reading and Literacy

Dr. Sellers presented information on elementary reading and literacy, including the process to address elementary reading and literacy following direction from the Board, Committee members, District responsibilities related to reading literacy, the science of reading, the five components of reading, breakdown of the Wonders curriculum, ELD and Specialized Academic Instruction curriculum, assessments and benchmark results, intervention support, and next steps. Mr. Loo and Dr. Sellers responded to questions from Board members regarding ELD strategies, fluctuation in growth gaps, committee purpose, Wonders curriculum training, intervention during ELOP, and implementation of the Wonderworks special education curriculum.

### C. Instructional Services - Presentation: High School Ethnic Studies Update

Mr. Loo provided an overview of California law and provided background on the process and timeline related to Ethnic Studies curriculum implementation, the curriculum description, and teacher training, support, and collaboration opportunities. Mr. Loo then introduced the teachers who contributions to the Ethnic Studies presentation, including Mr. Hutton, Ms. Chappell, and Mr. Lynch (not present). Mr. Hutton and Ms. Chappell presented an update on their Ethnic Studies classes, including the course description, social location, highlights from the Éxito Conference at the University of California, Santa Barbara, accomplishments and challenges, examples of key instructional strategies and activities, and student reflections. Mr. Mercer provided an update on next steps, including course permanency, professional development, advertising strategies, and enrollment growth. Mr. Mercer responded to a Board

member's question regarding whether the enrollment numbers for Century Academy's online class were included in the presentation, and if there is an option for an in-person class for that site.

### D. Instructional Services - Presentation and Approval of Instructional Materials Adoptions for 2023-2024

Mr. Loo presented information on the instructional materials adoptions for the 2023-2024 school year, including a review of the highlights of Board Policy 6161.1 – Selection and Evaluation of Instructional Materials, prior and upcoming instructional material adoptions, a summary of the proposed materials, estimated cost, and next steps. Mr. Loo responded to questions from Board members regarding how the textbook adoptions were prioritized, DAC review of piloted curriculum, connection between Grade 5 Social Science and We the People curriculum, and the possibility of a transition to digital textbooks.

### E. Student Services - Approval of Amendments to Board Policy and Administrative Regulation 6164.4 - Identification and Evaluation of Individuals for Special Education

Dr. Egans provided background on the amendments based on Gamut language related to Child Find obligations and new law related to designating a main point of contact to coordinate and complete the transition from Part C to Part B of the Individuals with Disabilities Education Act (IDEA). The Board reached consensus to provide direction for District staff to work with Trustees Goldberg and Sylvester on verbiage changes prior to approval at a future Board meeting.

# F. Board of Education - Approval of Amendments to Board Bylaw 9310 - Board Policies Dr. McLaughlin provided background on the amendments based on Gamut language and responded to questions from Board members regarding verbiage revisions. The Board reached consensus to provide direction to District staff to revise the bylaw with the changes recommended by the Board prior to approval at the next Board meeting.

### G. Board of Education - Approval of Amendments to Board Bylaw and Exhibit 9323.2 - Actions by the Board

Dr. McLaughlin provided background on the amendments based on Gamut language related to a super majority, and responded to a Board member's question regarding whether the bylaw distinguishes between a super majority and a two-thirds vote. There was no Board discussion on this agenda item.

### H. Human Resources - Approval of Amendments to Board Policy 4119.1, 4219.1 and 4319.1 - Civil and Legal Rights

Mrs. Valentine provided background on the amendments based on new law, Education Code, and changes in Labor Code. There was no Board discussion on this agenda item.

### I. Human Resources - Approval of Amendments to Board Policy 4216 - Probationary/Permanent Status

Mrs. Valentine provided background on the amendments related to employee probationary and permanent status as it pertains to a merit district. There was no Board discussion on this agenda item.
