She also reported on a \$5,000 grant received from the Ventura County Credit Union to support the Conejo Closet, offered thanks to the Canyon Club and all involved for the event and support provided for the Westlake High School families that were affected by the recent tragic accident, and announced CSF's upcoming 20<sup>th</sup> Anniversary event.

#### 5. INFORMATION/DISCUSSION ITEMS – GENERAL

### A. Instructional Services - Presentation: Career-Technical Education (CTE)

District staff, including Mr. Mercer, Dr. Wilson, Ms. Cooper, Mr. Guerin, Dr. Looker, and Mr. Scalise, presented information on the District's Career-Technical Education (CTE) program, which included a program overview, districtwide key developments, program pathways and highlights from each high school and middle school site, and student and staff testimonials. District staff responded to questions from Board members regarding pathway completer programs, CTE opportunities for Century Academy students, Los Cerritos Middle School Woodshop program components, spending of dual enrollment grant money, roadblocks with community colleges related to dual enrollment, student feedback opportunities, pathway enrollment, relationships with local businesses for internships and work-based learning experiences, and program advertisement for targeted student populations.

#### **B. Student Services - Presentation: English Language Development Program**

Dr. Egans introduced Dr. Araiza, who provided information on the English Language Development (ELD) Program, which included a description of the ELD standards, details of the Home Language Survey, English Language Proficiency Assessments for California (ELPAC) and 2021-2022 ELPAC scores, designed and integrated ELD, reclassification process and rates, Federal Program Monitoring (FPM) audit and outcomes, Master Plan for English Learners, and the Master Plan for English Learners Committee goals. Dr. Araiza responded to questions from Board members regarding English Learner (EL) languages in addition to Spanish, creation of home survey questions, EL rate trends and challenges, connection between student success and intervention programs, support for EL reclassified students and those struggling to reach reclassification, difference in growth of students who do and do not attend the Newcomer Academy, process to monitor reclassified students, cultural acknowledgements in ELD classes, opportunities to connect ELD students together, communications to students and families for English Learner resources and supports, and target/current enrollment for the Dual Language Immersion (DLI) program.

## C. Instructional Services – Ratification of Los Cerritos Middle School Bell Schedule

Mr. Klinger provided background on the purpose and process of changing and ratifying the Los Cerritos Middle School bell schedule for the 2023-2024 school year and responded to questions from Dr. McLaughlin and Board members regarding CAPS training and the inclusion of the student feedback in this process.

## D. Human Resources - Approval of Amendments to Board Policy 4140 and 4240 - Bargaining Units

Mrs. Valentine provided background on the Gamut updates related to access to employee information and new employee orientations. There was no Board discussion on this agenda item.

# E. Human Resources - Approval of Amendments to Board Policies 4115, 4215, 4315 and Administrative Regulation 4115 - Evaluation/Supervision

Mrs. Valentine provided background on the Gamut updates related to the addition on professional standards for educational leaders and removal of language pertaining to No Child Left Behind. Dr. McLaughlin and Mrs. Valentine responded to questions from Board members regarding policy and administrative regulation alignment with the collective bargaining agreements, observation and evaluation processes and cycles, evaluation process for administrators, and communication to staff regarding the scheduling of observations and evaluations.

# F. Instructional Services - Approval of New High School Core Literature Title - The Distance Between Us

Mr. Loo provided an update on the scheduled webinars to review title for ninth grade reading and responded to questions from Board members regarding the title's alignment with the Ethnic Studies course and availability of this title in school libraries.

## G. Business Services - Approval of Amendments to Administrative Regulation 3516.2 - Bomb Threats

Dr. Hayek provided background on the proposed amendments related to AB 1352 and AB 2355 and responded to questions from Board members regarding the regulation's specificity to bomb threats and potential need for a regulation regarding other types of threats, a suggested title change to match the regulation's expansive language, and alignment to other threatrelated policies in Gamut.

## H. Business Services - Approval of New Board Policy and Administrative Regulation 3515 -Campus Security

Dr. Hayek stated that the proposed new policy and regulation had not been previously adopted by CVUSD and are aligned with other adopted policies and regulations related to campus security and safety issues. There was no Board discussion on this agenda item.

## I. Business Services - Consideration of Joining in on Social Media Litigation

Dr. Hayek discussed the option for CVUSD to join in or request more information on a current social media litigation involving school districts and responded to questions from Board members regarding the litigation purpose and details, potential cost and intended outcome of the litigation, and the district's responsibility for students' social media access. The Board reached consensus to postpone the decision on this agenda item for a future Board meeting.

During the discussion of this agenda item, Trustee Goldberg made a motion to extend the Board meeting to no later than 10:45 p.m., seconded by Trustee Powell. **Motion carried: 5-0, with a** *preferential "yes" vote from Student Trustee Lopez.*
