Trustee Gorback made the motion to approve the Settlement Agreement for Case OAH 2024030045, seconded by Trustee Powell. **Motion carried: 5-0**

Trustee Sylvester made the motion to approve the agenda as submitted, seconded by Trustee Powell. Motion carried: 5-0, with a preferential "yes" vote from Trustee Light.

## 3. ACTION ITEMS - GENERAL

# A. Student Services – Adoption of Resolution #24/25-01 in Support of National Hispanic Heritage Month

Trustee Gorback made the motion to approve, seconded by Trustee Powell. There was no Board discussion on this agenda item. **Motion carried: 5-0, with a preferential "yes" vote from Trustee Light.** 

## B. Student Services – Adoption of Resolution #24/25-02 in Support of Attendance Awareness Month

Trustee Light made the motion to approve, seconded by Trustee Powell. Board members commented on the importance of this resolution. **Motion carried: 5-0, with a preferential** "yes" vote from Trustee Light.

## C. Board of Education - Approval of Employment Contract with Superintendent

Trustee Gill made the motion to approve the employment contract with the Superintendent, seconded by Trustee Powell. President Goldberg read the following statements regarding the employment contract with the Superintendent:

- 1. The approved Superintendent contract will begin July 1, 2025, and run through June 30, 2029. Upon receipt of a satisfactory evaluation of the 2025-2026 school year, this Agreement will extend through June 30, 2030.
- 2. The Superintendent's base annual salary shall be \$308,140.00, which is a reduction of 2.88% from his current salary, in order to allocate funds toward a different position for the 2025-2026 school year.
- 3. The Superintendent's salary shall be adjusted to provide the same general across the board salary increases provided to other District certificated management personnel each school year, if any. Please note that upon receiving a positive evaluation, the Superintendent will receive a two percent salary increase.
- 4. This contract requires the Superintendent to render a work year of 220 days, with up to a maximum of 10 additional work days each year, paid at the Superintendent's daily rate.
- 5. The Superintendent will also be compensated for longevity and earned advanced degrees in the same manner as other District certificated management personnel.
- 6. The Superintendent shall be entitled to all statutory benefits as a certificated employee, including 12 sick days per year, as well as the same health, dental and vision benefits provided to other District certificated management personnel.
- 7. The District shall provide the Superintendent with ten (10) year term life insurance with a face value of approximately three (3) times the salary of the Superintendent.
- 8. This contract includes fringe benefits in the form of expense reimbursements including mileage, and membership dues to professional organizations and committees. The Superintendent' shall be provided with an ACSA disability policy for each year of the agreement, not to exceed \$1,000 annually.
- The District shall provide the Superintendent with a mobile phone and a computer to use for District business and shall provide for the service fees associated with the approved District devices.

10. Per Government Code 53262 and 54953, copies of this contract will be made available upon request.

There was no Board discussion on this agenda item. Motion carried: 5-0.

# D. Business Services – Authorization to Perform a Full Financial Audit of the Thousand Oaks High School Football Booster Club

Trustee Sylvester made the motion to approve, seconded by Trustee Powell. Dr. Hayek provided background on the Board's legal fiduciary responsibility and the district's ability to perform a full audit on any school connected organization. Dr. Hayek clarified that the request for a full audit is related to a personnel issue and responded to a Board member's question regarding whether a report on the audit findings will be provided to the Board. **Motion carried:** 5-0, with a preferential "yes" vote from Trustee Light.
