5. INFORMATION/DISCUSSION ITEMS – GENERAL

A. Instructional Services – Presentation on Universal Design for Learning (UDL) Best Practices Dr. Sellers, Mr. Frank, Dr. Araiza, and Ms. Lee provided an update on Universal Design for Learning (UDL), which included a review of UDL as an instructional framework, how UDL supports all learners, implementation timeline, UDL principles and common practices, student engagement, multiple means of engagement, representation, and expression; Multilingual Learners engagement strategies, and UDL best practices at school sites. The presenters responded to questions from Board members regarding implementation strategies, how discussions and collaboration are facilitated across teachers and schools, anecdotal evidence of UDL alleviating student behavior issues, and differentiation of UDL professional development for age/grade levels.

B. Instructional Services – Discussion of Administrative Regulation 5116.1 – Intradistrict Open Enrollment

Mr. Loo provided background on the annual review of Board Policy and Administrative Regulation 5116.1, and stated that updates to the Administrative Regulation related to timelines for the 2025-26 school year, the new opportunity for the School Choice process to be run through the Q parent portal, and the identification of a July 1st deadline for School Choice applications for returning students. Mr. Loo responded to a Board member's request to clarify

the definition of a "returning student," and addressed a correction needed on page 4.

C. Human Resources – Discussion of Board Policy 4033 – Lactation Accommodation Mrs. Ashmore stated that the proposed amendments are Gamut updates related to district requirements to provide a reasonable break time and place for lactation and requirements to follow Title IX grievance procedures when investigating and resolving complaints based on alleged conduct involving sex discrimination or sex-based harassment. There was no Board discussion on this agenda item.
