5. INFORMATION/DISCUSSION ITEMS - GENERAL

A. Student Services - Presentation: Update on Mental Health and Wellness Services

Dr. Chamberlin-Scholle presented a three-year recap on Mental Health and Wellness Services, which included department and staffing growth, expansion of services and partnerships, 2024-25 grant funding, elementary, middle, and high school wellness services participation and services provided; university partners, in-house collaborative education, sustainability, Children and Youth Behavioral Health Initiative (CYBHI) areas of focus, and changes to the Medi-Cal billing and reimbursement process. Dr. Chamberlin-Scholle responded to questions from Board members regarding an overview of CYBHI and its effect on reimbursement, CYBHI implementation timeline, examples of schoolwide wellness events, and percentage of wellness services provided during unstructured and structured class time.

B. Business Services – Approval of Resolution #24/25-14 Authorizing the Issuance of Conejo Valley Unified School District (Ventura County, California) 2024 General Obligation Refunding Bonds

Mr. Kim from Piper Sandler presented a review of the General Obligation Bonds and Refinancing Opportunity, which included a history of the district's General Obligation Bonds (Measure R and Measure I), Measure I projected tax rates, Ventura County school district 2024-25 tax rates, bond interest rate index, summary of the bond refinancing opportunity in today's market, estimated savings to taxpayers, and next steps in the refinancing process. Mr. Kim responded to questions from Board members regarding interest rate uncertainty and the benefit of refinancing at this time, when these bonds became eligible for refinancing, and whether another credit rating will be assigned once the bonds are issued.

C. Human Resources – Discussion of Board Policy 4157, 4257, 4357 – Employee Safety Mrs. Ashmore stated that the proposed amendments reflected changes from Gamut related to Senate Bill 553, which requires the district to establish a workplace violence prevention plan, provide employees with training and a system to record incidents of violence, and maintain an incident log. There was no Board discussion on this agenda item.

D. Comments - Board of EducationBoard members provided comments.

E. Comments - Superintendent

Dr. McLaughlin stated that he had no comments.
