Adolescent Sexual Health Work Group (ASHWG)

- CDE does provide "Curriculum Guidance" from the Adolescent Sexual Health Work Group (ASHWG)
- ASHWG is an organized collaborative of governmental and non-governmental organizations (NGO) to promote and protect the sexual and reproductive health of youth in California. ASHWG is comprised of program managers from the California Department of Public Health (CDPH), California Department of Education (CDE), and key NGOs committed to working more effectively to address the sexual and reproductive health of California adolescents since 2003.



ASHWG Sub-Committee (2016)

- In June of 2016, a group of eight educators were recruited via ASHWG to form an ad-hoc ASHWG sub-committee charged with reviewing a subset of comprehensive sexual health education curricula for alignment and compliance with the CHYA.
- The sub-committee included "a diverse group of reviewers that represent a number of areas of expertise; have experience working in the field of sexual health education; and who are not linked to the publishing companies of any of the curricula included in the review. We also coordinated the group to include the HIV/STD Prevention Specialist from the CDE in order to provide expertise on the interpretation of the CHYA."



ASHWG Sub-Committee Curricula Review (2016)

- In 2016, ASHWG reviewed the following comprehensive sexual health education curricula:
 - o FLASH (MS, HS)
 - Teen Talk (MS, HS)
 - Positive Prevention Plus (MS, HS)
 - Rights, Respect, Responsibility (MS, HS)
 - Making Proud Choices, CA Edition (MS, HS)
 - Be Real, Be Ready (MS Only)
- A <u>summary chart</u> of these reviewed curricula is available that provides basic information (e.g. year last updated, lessons reviewed, time per lesson, supplemental materials, cost, training support, and online location).

Updates to CHYA (2019)

- Since the ASHWG ad-hoc curriculum review in 2016:
 - Effective, January 1, 2019, CHYA was updated to include required instruction about human trafficking and the role of social media
 - All previously reviewed curricula added updated content
 - New comprehensive sexual health education curricula were published
- Therefore, the existing 2016 ASHWG reviews do not provide an up-to-date or accurate curriculum analysis alignment and compliance with the CHYA.



Staff's Recommendation

Instructional Services recommends that the following curricula be considered as part of the District's adoption process:

- **Positive Prevention Plus** Most commonly adopted locally (\$9,870 one-time for teacher materials, ~\$20,272 annually for student materials)
- Rights Respect Responsibility Informal recommendation of ASHWG (Free, Google)
- Teen Talk Informal recommendation of ASHWG (\$8,850 one-time for teacher/student materials)



Adoption Process

- Teacher review and input this has been continuous & ongoing since 2016
- DAC feedback presentations are planned at several DACs
- SDAC sub-committee work input & feedback from various student groups
