Co-Curricular Programs, Athletics, Marching Band, Arts and Music Update



Co-Curricular Programs, Athletics, Marching Band, Arts and Music

- <u>Flyer</u> sent out to staff & families on June 11th
- Activities (Choir, Dance, Instrumental Music, Marching Band, Spirit Cheer) to reopen June 22nd
- Athletics to reopen June 27th with guidelines as per the latest orders
 - CIF "Dead Period" for CVUSD is June 13-26th
 - Sites will send out specific information with District guidance regarding dates and times per sport
 - Athletic Staff meeting planned to discuss safety protocols and guidelines
- Social Distancing Guidelines 6 ft. apart outdoors/12 ft. apart indoors as per Ventura County Public Health Orders regarding gyms and fitness facilities
- Conditioning and workouts only (no sport specific equipment permitted)
- Co-Curricular Practices & Gatherings organized into Cohorts ("Pods") as per CIF & Public Health:
 - Phase I pods 10 participants & 1-2 Coaches
 - Phase II pods 50 participants & 1-2 Coaches



Child Care and Summer Camps Update



Child Care Summer Camp

- YES! We will be OPEN for our CHILDREN from June 29 August 7 in one week programs
- Registration starts June 15, with priority given to "essential" workers
- Camp schedule will be from 9 am to 3 pm. We recognize restrictions have not been completely lifted and we are making an effort to limit exposure between students and staff while allowing custodial staff time to clean and disinfect before students arrive and after they leave
- Camps will be at Earths, Madrona and Sycamore Canyon
- Enrollment will be limited to 40 students per site:
 - The 40 students at each camp will then be divided into 3 groups and work from separate rooms.
 - Each group of students will remain the same throughout the week at camp, and students will remain with the same staff members during the week.
- Staff have participated in COVID-19 training, covering topics mandated by CDC
- Staff and students' temperatures will be taken upon arrival and a Visual Wellness Check completed
- Drop-off/pick up will occur curbside to limit the number of people in a classroom
- Staff will be required to wear face masks. Recommended for students.



Wonder Summer Camp

- Registration starts June 15, with priority given to essential workers
- Camp will operate June 28-August 6. Camp is Tuesday/Wednesday/Thursday from 8 am-12 pm (exploring feasibility of a M-F program with staffing being the challenge)
- Licensing regulations stipulate a ratio of 1:10 and groups no larger than 10 for ages 3-5. We will limit enrollment to 20 students.
- Staff have participated in COVID-19 training, covering topics mandated by CDC
- Staff and students' temperatures will be taken upon arrival and a Visual Wellness Check completed
- Drop-off/pick up will occur at the gate
- Staff required to wear face masks. Recommended for students.



Reopening of CITY CENTER (State Preschool)

- City Center State Preschool will reopen on July 1, but only to accommodate our state preschool students.
 - Obligated under our contract with the State to resume operations for funding
- Licensing regulations stipulate a ratio of 1:10 and groups no larger than 10 for ages 3-5. State preschool has 20 students and we will accommodate them all
- Drop off/pick-up would take place in the lobby. Temperatures will be taken and a wellness check completed for both students and staff
- Students will remain in the same classroom with the same staff until restrictions and/or licensing guidelines change.
- Staff have participated in COVID-19 training, covering topics mandated by CDC
- Staff will wear facemasks while with children. Recommended for students.
- Snacks and lunch would be provided by Child Nutrition.
