# California Legislation Framework for Public Facility Management

- The California Civic Center Act (*Education Code Section 38130*) authorizes a school district to grant the use of school facilities or grounds as a civic center, for specified purposes, upon terms and conditions deemed proper by the governing board.
- In September 2012, Senate Bill 1404 expanded the definition of direct costs to include capital costs, establishing a consistent method by which school districts calculate fees for the use of school facilities or grounds by outside entities.
- In August 2016, Assembly Bill 1557 amended the Civic Center Act to state that a recreational youth sports league is considered a non-profit only if it charges participants an average of no more than \$60 per month.
- Passed in September 2019 and in effect until January 2025, Assembly Bill 1303
  expanded on SB 1404 to authorize, and sometimes require, that a school district
  charge community groups for the direct cost of facilities, which includes operating
  and admin costs.



#### Facility Use 101

- The joint use of public school facilities offers educational, economic, and environmental benefits for both schools and communities.
- The public has a right to utilize school facilities, albeit under approved Board of Education policy.
- As a result, the facilities wear down much faster than they should.
- Facility use fees should go to ensuring proper maintenance of school facilities.
- A cost recovery analysis helps the district understand how much it should charge in order to recoup its costs and improve maintenance and upkeep of its facilities.
- The district uses Facilitron, which is an automated reservation and scheduling tool, that also gives access and insight into data.



#### How do we calculate Direct Cost(s)?

- 2019 AB 1303 defines direct cost: "Direct costs" to the school district for the use of school facilities or grounds means the costs of supplies, utilities, janitorial services, services of school district employees, and salaries paid to school district employees directly associated with the administration of this section necessitated by the entity's use of the school facilities or grounds.
- Creating a fair fee structure that covers costs to ensure long term maximization of tax payer dollars can be challenging for districts.
- In order to determine the district's hourly direct cost for operating and maintaining facilities, we use a formula originally introduced by the Center for Cities & Schools, based out of the University of California – Berkeley, and the 21<sup>st</sup> Century School Fund, in Washington DC.
- The non-profit organizations came together to build this joint-use calculator to help districts better understand how to calculate their direct costs for operating their facilities from their expenses, leading to better management of their facilities in the long run.

#### **Cost Analysis Equation**

(Operating Costs + Program Costs + Capital Costs)
Total Square Footage = Facility cost per square foot

Average SF per Facility x Facility Cost per SF

Total Usable Hours

= Facility cost per hour

- Operating Costs Source: 2018-19 District data
  - Utilities, repair costs, custodial and maintenance workers' salaries
- Staff Costs Source: 2018-19 District data
  - Staff salaries proportionate to the amount of time they spend on facility use management
  - Cost of platform used to manage facilities
- Capital Costs Source: Commercial Construction Index
  - Annual replacement cost for a facility

(SF of the facility type) x (\$/SF replacement cost)

Depreciation Schedule = Annual Capital Cost

- Last fiscal year, the District recovered \$697,936 in total fees of its \$2,637,706 direct cost to operate those facilities (26.5%).
- The highest utilization of facility space by external groups was for grass fields, with 26,477 of 48,513 total hours of use (55%), with only 5% of the direct costs recovered.
- Currently, non-profit groups are charged a fraction of the District's direct costs, and some are charged nothing at all.
- The gap between the District's direct costs and what was recovered by external organizations was \$1,939,770 for the 2018-19 fiscal year.
