

# **Committee Overview**

## Charge of the 2023-2024 Committee



### Provide suggestions and feedback on the new 2024-25 LCAP in real time as it is developed

### **Previous LCAP**

Comprehensive, strategic plan for all students

### New LCAP

Focused on unduplicated student groups (Foster Youth, Homeless Youth, English Language Learners, and Socioeconomically Disadvantaged) and student groups in **Red** (for California Dashboard indicators) at district and site level

Not all student groups are included as a result of targeted purpose and reduced scope

New major function as a deficit accountability plan

- Our committee faced challenges of evolving requirements and changing purpose of LCAP as a deficit accountability plan
- Committee's flexibility and patience were critical to our ability to "build the plane as you fly it"

# **Highlights of Committee Contributions**



### **LCAP Metrics:**

- Moved metrics across goals (i.e. EL Progress, Graduation Rate)
- Added California Alternate Assessment (CAA)
- Added annual survey responses
- Added descriptions of the CA Dashboard Local Indicators
- Added New Teacher Induction metric
- Adding SEL effectiveness survey results from students

### **LCAP Actions:**

- Added efforts to recruit staff with diverse backgrounds
- Added additional actions on promoting impacts of positive attendance
- Updated Disability History Month to March
- Added English Language Development training
- Expand restorative practices training to counselors and teachers

### **Improving Readability:**

- Infographic (<u>link</u>) with links / QR codes
- Streamlined formatting (<u>link</u>) bullet points, links, straightforward

### **Other Key Contributions:**

- Proposing updates to LCAP goal language (<u>link</u>)
  - Including language to incorporate Equity and Access values
  - Mental Health added to Goal 4 language
- Integrating aligned plans with 4 goals, includes links and aligned actions in "goal explanation"
- Updates to SPSA memo and SPSA monitoring and accountability tool (rubric) to target and address gap between district and site level for student groups in Red (California Dashboard indicators). The student groups in the Red for an indicator do not largely match up between the district and school sites. There is a need for further coordination of SPSA and LCAP goals, metrics, and actions.

# **Takeaways & Recommendations from Committee**



### Takeaways:

- Honest conversations were critical to produce a better LCAP product for our community
- Updated infographic is accessible and data driven
- Ongoing process to engage with educational partner groups is critical to improving LCAP
  - Committee included a range of individuals that represented diverse views and perspectives
  - Synthesized these diverse inputs into larger concepts within LCAP
- Focus on metrics is appreciated
- Committee participation and attendance has improved
- Streamlining goals and metrics increased accessibility and readability → improved likelihood of engagement/understanding
- CDE requirement to target **unduplicated students** (Foster Youth, English Language Learners, Socioeconomically Disadvantaged) and **lowest performing student groups** created a huge shift in scope and purpose for LCAP
- Gap between District and school sites demonstrated need to further coordinate SPSA and LCAP goals, actions, and metrics
- Embedding plans improved LCAP

### **Recommendations for Next Year:**

- LCAP:
  - Deeper look at adjusting some of the LCAP metrics (metrics not required)
  - Monitoring progress of the LCAP goals and metrics as it begins 3-year cycle. Adjust as necessary.
  - Further need to discuss and explore on certain topics (ex: College and Career Indicators and DEI)
- Homework may not always be needed
- Bring the BUDGET back in the LCAP BUDGET committee!
  - Shift from focus on LCAP to a targeted budget focus
  - Evaluation of ROI for line items/programs
    - Analysis of cost of programs with analysis of how (and how many) students are served
    - Reminder that an evaluation system exists (ex: ROI matrix/rubric, decision tree, and quadrants)
- Further contributions needed...
  - Instructional Services Directors with grade span oversight are needed to better vertically articulate successes
  - More input from Classified Personnel
- Clear written directions and charge(s) given to the committee EARLY
- Realignment and possible expansion of other district plans that are noted in the LCAP
