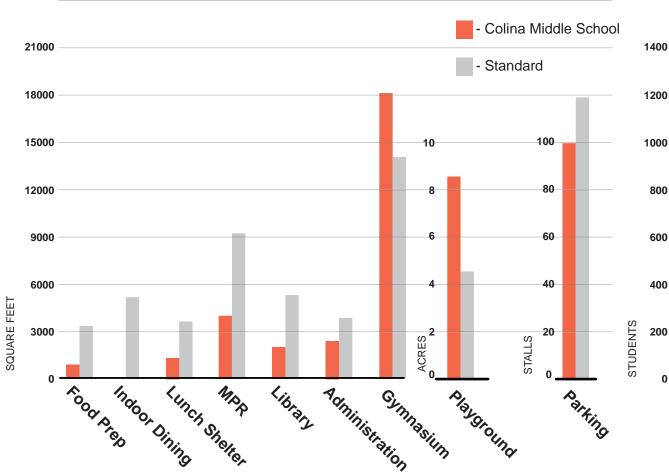


Challenges Summary:

- Administration Building and Multi-Purpose Building HVAC systems and roofing are aging
- Interior and exterior finishes are aging
- Portable buildings are aging
- Parking lots & drop-off zones are undersized

- Congested lunch time queuing
- Campus perimeter fencing is low

- Lunch Shelter (-2,277 SF)

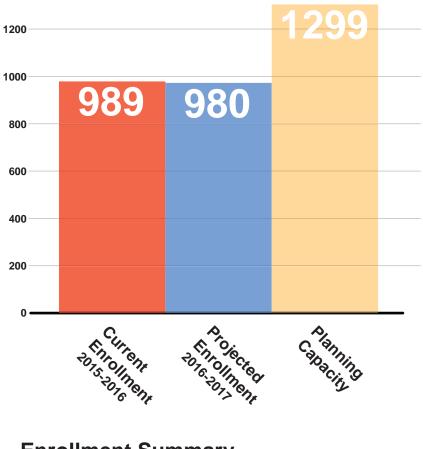
- Indoor Dining (-5,196 SF)

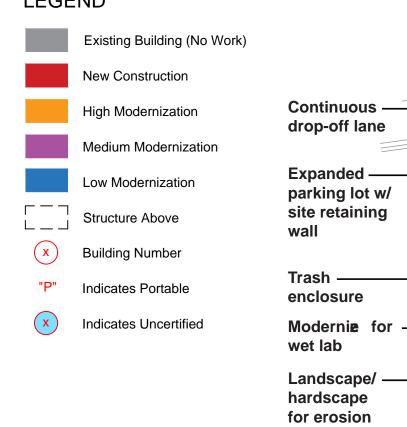

- Addition of shade structures & enhancement of courtyards, including 6th grade corridor
- Expanded parking & integration of continuous drop-off lane
- Sloped walkway at field transition with spectator seating
- Landscape/hardscape south of t-ball fields
- General accessibility upgrades
